Comments: Dear John Gale, I write on behalf of the residents of 44, 46, 48, 50 & 54 Haydock Road to object to the above planning Application. We object on the grounds of the position of the secondary pedestrian entrance. The location of this entrance is at the end of a section of Haydock Road which is a private road and is not planned to be adopted by the Council. The residents of this section of Haydock Road believe that placing a pedestrian entrance in the current location will increase the number of people using this private road or grassed area that runs parallel to it as a right of way. This increased footfall will result in a significant impact on the local environment with increased littering/chewing gum. As we are the owners of the road it will fall upon us to undertake any required maintenance and repairs at our

own expense.

This point was raised by a number of us at the public consultation held at St Edburg's Primary School on the 10th October 2017 and we are disappointed that these comments have not been acted upon prior to the application being submitted. A simple solution would be to move this secondary pedestrian entrance further down toward Pioneer Way so it links up with a road that will be adopted.

We hope this will be given due consideration. Please confirm receipt and formal registration of this objection.
