At Cedar Court we hope to continue to enhance the "treescape" enabling the best specimens to thrive. In 2016 we were advised , during a site visit here, by Cherwell District Council's representative that we would be given permission to fell any sycamore trees on our land, given that we have plenty of other finer trees on the property and that over the past seven years we planted many more ornamental and smaller trees.

There is a potentially excellent ,large ,**mature sycamore** in our neighbour's garden adjacent to some of our trees at our southern boundary(**Labelled 3 on the sketch map**). This tree is not only beautiful but an owl box which has been placed in it has been used successfully by tawny owls. We would all like to see this tree reach its full potential. Currently it is impeded from doing so by the **sycamore** near it which is in our garden(**labelled 1 on the sketch map**) which as can be seen from the picture is stopping the larger tree from developing. There is also a young **Holm Oak tree** inbetween both trees(**2 on the sketch map**). Again this is not being allowed to grow well and make a good shape by the **Sycamore number 1**.

We are therefore seeking permission to fell **Sycamore Tree Number 1** on the sketch plan in order to preserve and enhance the two other trees mentioned.

You may see from previous applications that we love trees and care about their well-being and potential and hope that by removing this sycamore tree the southern boundary of our garden will become a better environment for all including wildlife.

We do hope that you will consider our application favourably,
