British Bakels manufacture bakery ingredients ranging from Caramels, custards, sauces, glazes, toppings, Hot Cross Buns, and Bread mixes to supply large supermarkets, industrial bakeries, small bakers, and Food Service industries who then use our ingredients to make the end saleable products. To make these products we use steam for heat and glycol water chillers to cool, both manufacturing plants use various mixers to blend raw materials to make the final products, these production areas have Air Handling Units to ensure we have a comfortable working environment for our 210 employees. The two new enclosures will house-

A) New steam generating boilers at end of main building, relocating the old inefficient boilers to a better location as current are in the middle of the plant having been enclosed when previous expansions have happened, these steam generating boilers provide heating for our mixing vessel. The new boilers make use of latest technology to maximise efficiencies, this enabling remote monitoring of the system, being also designed for later use with Hydrogen as a fuel source.

B) New additional enclosure being part of existing extension previously approved – This is to relocate the old dust extraction system for the dry production area, the existing units are over 20 years old and external, in moving to a new enclosures allows us to reduce noise and again make them more efficient as being internally located reduces the exposure to heat variations by using the heat extracted from the dusty air being extracted to reduce condensation of the units and compromising the effectiveness of the filter media.

In both areas there is no air conditioning or handling, although we will be recovering heat generated within the processes.
