I am writing in reference to the enforcement action currently being taken at the above site, concerning the archaeological watching brief as asked for in Conditions 4 and 5. I carried out a site visit on 15/03/2024, and discussed options with the contractor. Since this visit, I have been provided with more information regarding the raft foundations which have been utilised in this development. The provided plans show the foundations have been excavated to a depth of 250mm, to protect the tree roots on the site. A previous archaeological watching brief elsewhere on the property found that the archaeological horizon was approximately 300mm below the current ground level.

With the extra information provided by the contractor, I believe that archaeological remains will not have been disturbed by this development, and therefore enforcement action does not need to be taken. Would it be possible for the archaeological conditions to be discharged with a statement outlining the further information?
