PART DISCHARGE OF CONDITIONS 13 AND 36 PURSUANT TO OUTLINE PLANNING PERMISSION 14/02121/OUT AS AMENDED BY NON-MATERIAL AMENDMENT 22/03492/NMA AT HIMLEY VILLAGE, MIDDLETON STONEY ROAD, BICESTER

I write on behalf of Cala Homes (Cotswolds) to part discharge Conditions 13 (Future Climate Change Risks Statement) and 36 (Water Neutrality Statement) in relation to the first 500 dwelling area only, pursuant to Outline planning permission 14/02121/OUT as amended by Non-Material Amendment 22/03492/NMA at Himley Village, Middleton Stoney Road, Bicester.

Condition 13 (Future Climate Change Risks Statement) states:

"Each reserved matters application that includes the construction of any new buildings shall be accompanied by a statement setting out how the design of buildings and the layout has taken account of future climate impacts, as identified in TSB research 'Future Climate Change Risks for NW Bicester', or any more recent assessment that has been published, and how the proposed development will be resilient to overheating, changing rainfall patterns and higher intensity storm events."

I submit the following document in order to part discharge the requirements of this condition:

- Future Climate Change Statement – June 2023

Condition 36 (Water Neutrality Statement) states:

"Prior to the commencement of any development in a phase that includes the construction of

any new buildings, details of the strategy to work towards water neutrality, in accordance with

the Eco Towns PPS shall be submitted to and approved in writing by the Local Planning

Authority. Each reserved matters application that includes the construction of any new

buildings shall demonstrate how it contributes to and is in accordance with the approved

strategy."

- Carbon Emissions for Construction Process Report – June 2023

- Water Neutrality Statement - June 2023
