The general protection outlined for the hedgerow itself seems OK, my only concern would be that works should not occur as close as 1m to the hedgerow during the bird nesting season unless it has been checked first for nesting birds by a competent person. Should nests be present work could not commence until the last young have fledged. Working this close otherwise could cause disturbance which would be an offence. Otherwise no issues. Following further investigations at the site, I'm now advised by my client and the contractors that they consider the development can be carried out without the hedge needing to be removed temporarily during the works.

A method statement considering how the works will be carried out when working in close proximity to the hedge is attached. This details the establishment of a root protection buffer and how roots will be protected when working within the buffer.

I hope to be able to respond to the comments from the ecologist regarding external lighting shortly.

I have also picked up comments from OCC regarding the impact of the scheme on car parking – do these also need to be addressed? You haven't mentioned them but note they have been on the system a little while now.

Emma,

Following the emails below, I wonder whether you are in a position to respond yet? The Council's Ecologist has also expressed her agreement with the concern raised by the Arboricultural Officer regarding the storing of the hedgerow for later re-installment and the request for additional information. She advises that an estimate of how long storage is likely to be needed for will affect the likely success of this proposal. She would also advise that a plan for full replacement of the hedgerow would be needed to include a survey of species currently present and preferably to be of better biodiversity value to present should be required if the replanting does not work.

She has also raised a concern regarding the 6m lighting columns to the west of the site which are within or adjacent to the 'existing hedgerow to be retained' as these are likely to unavoidably cause an unacceptable amount of light spill into the hedgerow if sited in that location. Their relocation further into the car park and their number reduced would be beneficial.

I am also still awaiting a response from Thames Water.

I wonder if you would be agreeable to an extension of time to enable the outstanding matters to be resolved? Depending upon the likely timescale for a response relating to the above, an extension of time until next Friday – 21 February 2020 may be achievable.

Emma,

I have been working through the above application and I am still awaiting a number of consultation responses but I have sought the advice of the Council's Arboriculturalist given the proposals relating to the hedgerow. He has some concern that removing and replanting the hedge will not be a success and he has raised the following points seeking further detail:

The report doesn't mention the size of the trees forming the hedge, or how long the hedge has been there. My concern is the longer the hedge has been there, the higher the chance the roots are intertwined, increasing likelihood of root damage when being removed individually.

The report doesn't appear to include any information on how long the hedge will be in the temporary pit for, it also does not give any information on the soil structure within this pit, and how it compares to the current hedge location. On a side note, the hedge as I understand is a 15m section, however is referenced as a 10m section under 3 – Lifting and moving.

Non invasive exploration of rooting zones has been mentioned within the report, can further details be provided on what equipment will be used for this?

The report does not include the process for re instating the hedge back to its original position.

Are you able to consider this and provide a response? I am keen to ensure that this proposal will succeed, however in any event, it will likely be necessary to impose a condition to reinstate a hedgerow in the circumstance that this relocation fails given that landscaping to mitigate for the pumping station will be necessary in terms of visual impact. I have also sought comments from our Ecologist as it also appears that the lighting scheme has changed?

I will chase other responses, including that of Thames Water and will be in touch if any further queries are raised.
