The comments below relate to the documents that were logged on the CDC Planning Portal on 19 March 2024.

The Cover Letter clearly spells out the changes that have been made following dialogue with the Local Highway Authority and Local Planning Authority. It is agreed that the alterations satisfactorily address the concerns and the previous reasons for objection.

It is understood that access points to individual dwellings are shown indicatively as they may be altered to accord with the residential parcel reserved matters layouts. The main entrances to the care home and the neighbourhood centre are shown.

Off-carriageway cycle facilities are indicated alongside all main streets, with 2m wide cycle paths on each side of the North-South spine road and 3m shared use paths on one side of the other streets. Bus stop waiting areas are placed in the verges so do not conflict with the paths. On the east side of the red line area, a footpath connection to the south-east corner has been added to improve connectivity and the southern boundary cycletrack has been adjusted as discussed.
