

Recommended works – Highways

- 1- Tag 1 Sycamore Remove Major deadwood
- 2- Tag 8 Weeping Willow Adj. village pond. Reduce entire tree to final height of approx. 8m and prune sides to suit. Remove large snapped section. Sever ivy
- 3- Tag 9 Common Horse Chestnut Clear stem to approx. 4m and prune back from encroaching into road. Sever ivy
- 4- Tag 19 Norway Maple Lift lower branches to 2m to provide clearance for mowers and remove major deadwood
- 5- Tag 20 Lime Entrance to village hall carpark. Lift all round to provide 3m clearance
- 6- Tag 23 Oak Adj. Kirtlington Park pedestrian gate. Remove lower laterals encroaching into car park back to origin. Prune back the higher branches from roadway (but do not remove entire branch)
- 7- Tag 24 Lime Adj. Kirtlington Park pedestrian gate. Remove epicormics and clear stem to crown break
- 8- Tag 104 Common Horse Chestnut Growing within weeping Willow canopy. Fell and remove
