I write in relation to the above planning application, to which I would like to register my formal objection given that this proposal is not in accordance with the local development plan and there are no material foundations that would warrant permission to be granted to this case.

My objections are summarised in 8 sections:

1. Traffic Impacts

The proposal would present considerable adverse traffic impact which the existing road infrastructure cannot sustain. The addition of up to 1000 daily vehicle movements cannot be accommodated by the existing transport network, and even if visitors are guided away from local/rural roads, satellite navigation systems will direct visitors onto local roads that are unable to cope with such traffic volumes. The route through Little Chesterton is already a 'rat run', experiencing significant traffic levels (occasioned by visitors to Bicester Village) that the roadway was not designed to accommodate.

The A34 already experiences considerable difficulties, as does the Junction 9 of the M40. This development would only serve to exacerbate these existing issues and seriously inconvenience the local residents not only of Chesterton, but of Bicester and all of the surrounding villages. With the existing development in Bicester and surrounding areas (the new office development, retail park, Bicester Heritage, Kingsmere, Symmetry Park etc) this proposed development would increase pressure on an already-overloaded network, and this proposal is, therefore, in the wrong location.

2. Economic Benefit to the Local Area

Local businesses do not support Great Wolf's assertions of economic benefits. The development's aim would be to retain all visitors on site, and to retain all associated expenditure – no benefit would therefore accrue to local businesses.

There is little real unemployment in the area, and local businesses already struggle to recruit staff members. As a result, Great Wolf would either transfer employees from existing businesses, or would bring employees into the area from outside – therein exacerbating the traffic issues through increased vehicle movements. The Council's stated aim is to prioritise Knowledge-based business investment, thereby driving employment associated with the Knowledge Economy. This proposal is contrary to this stated aim of the Council.

3. Landscape

Great Wolf is seeking to construct half a million square feet of building on what is an existing greenfield site. This development will be irreversible, and will have considerable impact on the local countryside and views of the site.

4. Sustainability

The proposed Great Wolf development is in a wholly inappropriate edge-of-village location. The proposal indicates the establishment of a 900 space car parking facility and therefore is heavily reliant on car travel to and from the site. This is contrary to the Cherwell strategy of reducing car usage.

The existing golf club members will now be forced to travel to other courses, in so doing increasing their level of vehicular emissions. (NB. The remaining 9 golf holes would not constitute an acceptable solution for the club golfer.)

The development of the site would irrevocably disrupt ecological habitats. The area is currently the home for many species which would be disrupted and threatened as a consequence of the removal of the existing habitats.

5. Pollution

Outdoor leisure facilities proposed by Great Wolf Resorts would be adjacent to an increasingly busy motorway which would surely be a health hazard in terms of exposure to noise and fumes.

The deterioration of air quality and the increase in pollution caused by traffic increase (plus construction and delivery vehicles) would be considerable and this must be considered in relation to the health of not only the visitors, but also to local residents.

6. Design

The site design is inefficient in that to reduce visibility, the site has been spread across a considerable area. The design is not in keeping with the local area where existing buildings and newer schemes are of small scale buildings at low height. These enhance the historic character of the area as outlined in Cherwell Council's Countryside Design Summary, 2008

7. Sports and Recreation

The golf facility represents a thriving local club which presents as a viable commercial concern. The loss of 9 holes will drive many members away from the golf club and therefore the only 18 hole course in Bicester will be lost. With the additional loss of North Oxford Golf Club to housing development, the provision of sports facilities in the North Oxfordshire area is being damaged. The golf club provides considerable community function, and to permit its denudation would be a substantial loss to the area.

There remain considerable concerns that Great Wolf will remove the remaining 9 holes in due course, as they build demand on the new site.

8. Lack of consultation, lack of need

The proposal will undoubtedly have a significant impact upon the local area and Great Wolf should have worked with Cherwell to be allocated a more appropriate site through the correct local plan process. This is a speculative planning application in the wrong location and should be refused both on this basis, and on the clear lack of need for such a facility in this area.

For the above reasons, I strongly request that the appeal should NOT be granted for this application. This development has been demonstrated not to be either necessary or beneficial through the original planning process, and I would urge you to refuse this appeal

I wish to strongly object to the above mentioned application on the grounds that this proposal is not in accordance with the Local Development Plan.

Having grown up in the village, it is devastating to hear of the impact that this development will have on the already quickly disappearing green space around the village. The location of the Great Lakes resort seems entirely inappropriate based on the size and infrastructure of Chesterton. Cherwell's strategy of reducing car pollution seems to have been ignored in this application. given the large 900 space car park, and the projected additional c.1000 extra daily car movements. Chesterton has increasingly become a cut through for commuters and becomes very congested whenever there is a traffic problem on the surrounding A34 or M40. There is already so much development ongoing in Bicester; with little change to local roads, that they are already stressed and cannot cope with additional pressure.





I am writing to whole-heartedly object to this application for a large-scale water theme park in the small village of Chesterton. This is not a facility that can be shown to have a need for provision, in this area or any other.

The current golf course is a greenfield site providing a sporting facility which will be lost to a vast inappropriately sized concrete area with large uncharacteristic buildings for a small village. The plans for a 900 space car park indicate the anticipated huge volume of extra traffic that will be travelling to and from the site, bringing with it a substantial increase in noise pollution, not to mention a decrease in air quality and potentially adding to the associated health issues currently being identified nationally.

This will be a private resort attracting a proposed 500,000 visitiors annually. As all these visitors must arrive by road this is going to add unprecedented stress to the already highly congested M40, A34, A41, A4095 and B430. The infrastructure of the area will simply not be able to sustain this proposed development, to the detriment of thousands of local residents and businesses. The congestion on these roads is already well known even on a national scale, rarely does a day go by without the mention of an accident or excessive delays on these routes.

It will comprise 500,000 square feet of building on a greenfield site, irreversibly removing important green space and disrupting ecological habitats for an abundance of wildlife. The design of the buildings is neither small scale or detached and therefore not in keeping with the character of the local area.

There are questions as to how this development will be staffed. There is virtually no unemployment in the entire county of Oxfordshire. Local businesses are already finding it hard to recruit staff and Great Wolf will be targeting this small pool of people. Either staff will be poached from local business or more likely staff will be recruited from a considerable distance. These people will have to use road transport – at best brought by private bus, at worst adding to the number of cars on the road. As there is to be no accommodation provision for staff, these traffic movements will add to the traffic problems detailed above. I wish to object in the strongest possible terms to this application for a large-scale water theme park on the edge of the village Chesterton.

The existing road infrastructure cannot cope with the projected extra 1,000 + daily car movements. Chesterton is already a 'rat-run' and experiences major congestion as an escape route during the many traffic issues on the M40 and A34. Bicester is a growth town and with the huge amount of new homes and businesses that have been built in the last few years comes an equally enormous increase in local traffic. It is unacceptable for this development to add to the already completely overstretched A34, A41, A4095 and B430. There will be a serious deterioration in air quality and a substantial increase in noise pollution for local residents. The plans for a 900 space car park confirm the expected level of cars and vehicles.

Economically there is very little benefit from this development for the local area. Oxfordshire has very low unemployment. The resort's requirement for 600 lower skilled staff will either attract employees away from existing local businesses or necessitate finding staff from some distance, thereby increasing road movements even further. I am writing to whole-heartedly object to this application for a large-scale water theme park in the small village of Chesterton. This is not a facility for the benefit of local residents.

The existing road infrastrure (and that of the surrounding villages) cannot cope with the addition of up to 1000 vehicles on a daily basis. Chesterton is already a rat-run and experiences major traffic congestion as an escape route during the many problems that arise on the M40 or A34. The suggested routing to this development will cause excessive congestion on the A41,B430 and of course the A4095 which runs directly through the village. This enormous traffic issue points again to the fact that this proposal is in the wrong location.

The current golf course is a greenfield site providing a sporting facility which will be lost to a vast inappropriately sized concrete area with large uncharacteristic buildings for a small village. I am writing to you to ask you to defend the position taken by Cherwell District Council when they unanimously rejected the planning application by Great Lakes UK (Great Wolf Lodges) earlier this year to erect a Supersized warehouse style resort on the edge of Chesterton.

This type of facility is simply not needed, it is not in the local plan, it is not a leisure facility to be enjoyed by the locals and will bring them nothing but noise, flooding and traffic.

Chesterton is an idyllic country village, with a picturesque and popular pub just opposite the church with the village green in between. This proposal will bring an additional 1800 cars PER DAY through the village, which has a school on the only road through it. There is already such an issue with traffic at school pick up and drop off times that the Parish Council have recently been considering double yellow lines near the school.

You might say that designated signs to direct visitors to the resort away from the village might be adequate, however, these days everyone simply types a postcode into their Sat Nav and follows that - if the traffic is building up in one direction, the traffic will be sent through another village or through a tiny residential road, not expecting such a throughput. One of the routes Sat Nav currently brings cars to Chesterton from London is through Little Chesterton -a single track road!Bringing this type of resort to a small village is simply not a good idea.

Great Wolf Resorts are usually housed on the edges of cities, not in a rural environment and it would appear that as this is their first location outside North America, they are trying to buy cheaper rural land to escape more expensive urban land prices. Quite simply, this does not fit here.



OBJECTION TO GREAT WOLF RESORTS CHESTERTON

Alison

I wish to register my objection to the appeal by Great Wolf Resorts against the rejection of the proposed holiday/water park they wish to build in the neighbouring village of Chesterton.

There are a number of reasons why, as a resident of Kirtlington, I feel strongly that this development would be disastrous for our local environment, and create impossibly dangerous and deleterious traffic conditions.

- The capacity of the park would mean up to 1800 additional cars passing along local roads every day. Whilst the A4095 is classed as an A road, it is a twisting country road with dangerous bends, risky junctions, narrow sections where cars are parked and already full of potholes. It is entirely unsuited to this increase in traffic.
- Visitors will inevitable use satnav rather than road signs to reach the resort and a quick look on Google Maps will show that cars will be directed through either the dangerous junction of the A4095 and B430 if travelling from the west or from the South via the A34 through the single track road passing the tiny village of Little Chesterton. Not only will this apply to visitors to the park but of course to all the heavy construction traffic. The A34 and M40 are frequently closed at which point our village road becomes a diversion. This will bring all the traffic right past our village school and through our village which does not enjoy footpaths on both sides of the road. Do you believe that this number of drivers, unfamiliar with the locale and almost at their destination, will respect the risks this poses?
- We have the privilege of dark skies in the village with no street lights at all. Our night skies will be lost to the floodlights of a 900 space car park. This light pollution and needless energy use is just one of the environmental costs.
- We live in an area classified by the Environment Agency as "seriously water stressed". Why then would we seek to allow a Water Park which if typical of the GW resorts will use 42,366,077 gallons of water every year?
- Our local environment in all the surrounding villages is typified by cotswold stone houses and cottages. How then can a four storey hotel with an 84ft water tower be anything but a blot on the landscape.
- At a time when we need green space to improve wildlife sustainability and clean air to fight pollution from air and road vehicles, why approve a huge site with a 900 space concrete car park and an indoor pleasure park. We are in an outstandingly beautiful area with ample outdoor leisure pursuits.
- Great Wolf may argue that there will be economic benefits at a time of difficulty in the UK. The benefits will be for the US investors as the jobs it creates will be predominantly low skilled, low pay jobs and the facilities are not intended for local benefit. In the US 98% of guests remain on site for the entirety of their stay (much as Centre Parcs) and so there will be no spin off opportunity for local businesses and the local economy.

Chesterton is a small village without the wealth or power to fight a well funded organisation such as Great Wolf. Cherwell District Council unanimously rejected this plan having listened to the arguments and I would ask you to to do the same.

I do hope that you will take the opportunity to visit the area. Do use Google Maps and please beware of cyclists, pedestrians, children and horse riders.

I have copied this email to our MP in expectation that he will ensure that the Secretary of State is fully aware of local issues.

I am writing concerning the planning appeal reference APP/C3105/W/20/3259189.

The proposed complex is completely unsuited in scale to the proposed position.

Chesterton is a small and friendly village far enough from Bicester to feel totally rural and self contained. It is surrounded by countryside, but is under pressure. Children walk to the village school and cycle down the lanes independently, but this would no longer be possible if great wolf resort was built. The location of the proposed development on the outskirts of a small village with narrow rural roads is completely unsuited to the large scale hotel which hopes to attract half a million people a year, most of whom will be arriving by car. The position of the proposed hotel is such that whatever direction visitors arrive from they will have to travel the last leg down rural roads and through villages unsuited to heavy traffic. There is already substantial traffic pressure on the surrounding roads including the A34 and A41 from local traffic due to unchecked development around the Bicester area and large numbers of commuters, and no amount of developer funded 'road improvement' schemes help!

The scale of the proposed buildings is completely out of character with a rural setting - no effort has been made to harmonise the appearance of the building to the environment, or any consideration been given to the local vernacular architectural style. The plans show the hotel to be four storeys high and will dwarf and dominate the surrounding countryside. At 84 ft high the water tower will be potentially the tallest building in Cherwell and visible from the conservation area surrounding the listed buildings within the village.

The area is one of great water sensitivity, existing changes to the local area have increased the risk of flooding within the village of Chesterton and this will only increase further with the massive footprint of the development most of which will be buildings and hard standing. The fields around Chesterton act as a sponge soaking up excess water. without this and with additional water going into already failing water processing facilities this can only be a disaster to the village. The pumping station outside the village already spews sewage into open water courses at frequent intervals when rainfall and run off has been heavy.

Local lives will also be permanently detrimentally effected by permanently flood lit car park and light pollution from the development. It has been proven that not only would this be disastrous to local wildlife in what is a rural area, but also detrimentally effect residents sleep patterns and mental health.

Any perceived benefit to the local area is minimal, it is not a leisure facility that will be open to local people. the majority of visitors will not leave the site to explore the local area as facilities are provided on site for them and so will not contribute to the local economy. Wages in the hospitality sector are generally very low and largely attract foreign workers therefore being of little benefit to local job seekers.

In an era of awakening consciousness towards environmental sustainability this development seems completely inappropriate both in the position chosen, the scale and approach to the local environment.

Please take my objections into consideration.

I am writing on behalf of the North Aston traffic committee to object to the proposed development by Wolf Park Resorts at Chesterton in Oxfordshire. North Aston is a rural village in the adjacent Cherwell Valley a short distance to the west of the proposed development. I write specifically to object to the Great Lakes UK Ltd proposal of an US style water park for the following reasons:

1. The very high buildings proposed, including an 84ft high water tower, are completely out of character with the Conservation Area that was imposed on the village of Chesterton in the 80s. Those of us living inside this area are so strictly architecturally regulated (even to the type of roof tiles we can use) that to build such a large, high rise complex of floodlit buildings and car park WITHIN 600 METRES from The Conservation Area is totally inappropriate.

2. This proposed complex is to be set beside the historical Roman road, Akeman Street, which becomes known as Green Lane once it enters the village. In direct line from Green Lane, crossing Alchester Road, is The Lane. I live at Mill Cottage at the bottom of The Lane. On the evening of Sunday 16 August this year, after a very heavy rainfall, the Thames Water manhole in Alchester Road burst due to the surfeit of surface water. Several houses and the pub were flooded and a torrent of water poured all the way down the lane to the Gagle Brook beside my cottage. This house was only saved from flood by the quick thinking team of firemen who managed to shovel the mass of gravel carried down the lane by the heavy waters. They succeeded in forming a small dam of the gravel to direct the waters into the brook. In fact the garage and another outbuilding were flooded. My point is that if that 84ft WATER TOWER should burst I dread to think of the consequences to all these houses. We are at the lower end of a small incline which may seem slight but that volume of water would be very, very destructive.

I rest my case though there are many more reasons to object to this proposed project.

I am writing to you to ask you to defend the position taken by Cherwell District Council when they unanimously rejected the planning application by Great Lakes UK (Great Wolf Lodges) earlier this year to erect a Supersized warehouse style resort on the edge of Chesterton.

This type of facility is simply not needed, it is not in the local plan, it is not a leisure facility to be enjoyed by the locals and will bring them nothing but noise, flooding and traffic.

Chesterton is an idyllic country village, with a picturesque and popular pub just opposite the church with the village green in between. This proposal will bring an additional 1800 cars PER DAY through the village, which has a school on the only road through it. There is already such an issue with traffic at school pick up and drop off times that the Parish Council have recently been considering double yellow lines near the school.

You might say that designated signs to direct visitors to the resort away from the village might be adequate, however, these days everyone simply types a postcode into their Sat Nav and follows that - if the traffic is building up in one direction, the traffic will be sent through another village or through a tiny residential road, not expecting such a throughput. One of the routes Sat Nav currently brings cars to Chesterton from London is through Little Chesterton -a single track road!Bringing this type of resort to a small village is simply not a good idea.

Great Wolf Resorts are usually housed on the edges of cities, not in a rural environment and it would appear that as this is their first location outside North America, they are trying to buy cheaper rural land to escape more expensive urban land prices. Quite simply, this does not fit here.

Several homes in Chesterton flooded this year and in Little Chesterton there are ongoing drainage issues - an enormous complex with a car park for 900 cars will in no way help the current, already worrying, situation.

Indeed the ecological impact of this build would be nothing less than catastrophic - building over a popular golf course, with acres of rough ground supporting a huge variety of wildlife is not in line with the current government requirements to increase the biodiversity of each new build by 10%.

The site is currently a greenfield site and construction of this significant building would irreversibly remove important green space and disrupt ecological habitats for an abundance of wildlife. The proposed water tower would be the tallest building in Cherwell causing significant visual impairment while the proposed car park would rival the size of Bicester Village. The whole structure and design is totally out of keeping with the rural character of the local area, and with the Council's stated desire to tackle climate change.

As far as transport is concerned it is plain that the existing road infrastructure cannot cope with this extra development. Indeed the developments the Council has already approved (eg in Upper Heyford and on the outskirts of Bicester) will already exacerbate traffic problems in Middleton Stoney in particular. The prospect of a further 500,000 visitors per year which would mean circa 1800 car trips per day would just increase the air pollution and misery for local residents. This is an opportunistic proposal and the developer has no regard at all for the environment in which it is proposed to place it.

It has no merit as far as job creation locally or enhancement of the local economy is concerned. The resort will not in any meaningful sense be open to the public, there will be little to no interaction with local businesses and the 600 lower skilled jobs it claims to provide are either likely to disrupt existing businesses or add significantly to traffic movements as new employees travel some distance.

In summary this is an unwanted proposal which is not in line with the local development plan, would cause detriment to the environment, aggravate considerably the transport problems already faced in all our villages, bring no benefits to local communities and be an eyesore for miles around. I ask that the Planning Inspector dismisses this appeal and endorses the decision already made by the Cherwell District Council Planning Authority.

- This application was unanimously rejected by the Cherwell planning committee in March 2020 as being completely unsuitable for its location
- Chesterton is a small village and does not have the capacity to deal with the increase in traffic, noise and disruption
- The proposed development is not in accordance with the local development plan and due process should be followed

I wish to register my objection to the proposed appeal by Great Wolf Resorts which was unanimously declined by planners in March this year.

To build such a complex in the proposed location in Chesterton would be totally unsuitable for many reasons.

It would offer absolutely no benefit to the local community and would have a negative impact, not only on Chesterton village but on all of the surrounding villages.

I list below some of the many negative reasons.

• There are no plans to upgrade or alter our local road network to cope with the estimated 43% increase in traffic once built, and this figure doesn't take into account the impact of construction traffic which will be in the number of 65 lorries every day over a two-year period. Therefore our already poor country lane infrastructure will suffer much higher rates of deterioration, and there will undoubtedly be an increase in road traffic accidents.

• Disruption to wildlife both during construction and once built with the loss of natural habitat.

• High Water usage - The area is already classified as "seriously water stressed" by the Environment Agency.

• Lack of sewage and drainage infrastructure which will contribute to the already high risk of flooding in the area.

• Potential water fouling of the local area from chlorinated water waste (as with existing resorts in the US)

- Potential lack of recycling affecting local figures for CDC.
- Air pollution both during construction and once built.
- Noise pollution both during construction and once built.
- Light pollution both during construction and once built by nocturnal flood lighting.
- Loss of a popular leisure amenity.
- Loss of a countryside area of natural beauty.

As a resident and house owner in the village of Chesterton I am absolutely and wholeheartedly objecting to the appeal lodged by Wolf Resort against the unanimous decision to refuse their planning application. My reasons for doing so were spelled out in my letter of 16 December 2019, attached.

In addition to my previous points I particularly want to emphasise that the air pollution associated with the significantly increased road traffic around us, if this development is approved, will cause health problems for many residents. The current pandemic has demonstrated how individuals exposed to significant levels of air pollution are more susceptible to COVID-19 because their lungs are in a worst condition than those of people breathing less polluted air. In addition, studies triggered by the pandemic have highlighted that significant levels of air pollution negatively affect brain development in children and increase the occurrence of Alzheimer and respiratory diseases in older adults.

Health, to all of us, has become recognised as the single more important factor for a satisfactory life. In our neighbourhood we already have substantial levels of air pollution brought about by Bicester Village and its associated traffic. A second large scale development, the economic benefits of which go to a foreign company and the human health and environmental costs of which are borne by local people would fly against the UK taking the lead in climate change adaptation and mitigation.

I absolutely and whole-heartedly object to this application for a large-scale water theme park on the edge of our small village of Chesterton. There is no need whatsoever for such a development in the proposed location.

As a resident and house owner in Chesterton I know that property values will decrease with such an inappropriate development nearby. Indeed, this development is totally out of place and character in our small and old village. It is not in accordance with the local development plan and there are no material considerations that would warrant planning permission being granted.

Whilst the developer will benefit financially from this development, neither Chesterton nor the Cherwell area will get a share of these benefits. Staff will have to be hired from non-local areas as we have almost full employment locally. The business model of Great Wolf consisting of providing all facilities on-site to their visitors, local businesses will not be able to benefit from this theme park. Cherwell Council will benefit as Great Wolf will pay corporate taxes. The question then is: what are the costs which residents in Chesterton and other nearby villages will have to bear for Cherwell Council to see an increase in its corporate Council tax revenues? Is this in the public interest?

A first cost to the local community will be the additional traffic caused by 2000 visitors per day to the water-based theme park. Roads around the projected site and around the villages closest to it, are in a bad state of repairs because current levels of traffic are already extremely high. This significant additional traffic will further degrade local road infrastructure and result in increases in car accidents and air pollution. At peak traffic times it will be impossible for local residents to get anywhere, as currently is the case thanks to Bicester Village during sale periods such as Black Friday and all other sales over the yearly calendar. Increased air pollution has various deleterious health effects which local communities will have to bear. It also contributes to climate change and runs against the principles of

pro-active environmental management that are expected to be implemented by all local Councils following the Government's declaration of a national climate change emergency.

Various other deleterious environmental effects will be triggered by the building and operating of this resort. These include replacing a beautiful natural landscape by a built area of 500,000 square feet, displacing natural habitats, decreasing soil, plant and animal biodiversity and in the process changing the water cycle. All these environmental effects will contribute to climate change instead of slowing it down. Again, this is a counterproductive use of the area selected for Wolf resort since we are in a national climate emergency.

Once again, I absolutely oppose this un-needed resort as it will not benefit residents and businesses, given its business model, and it will create a string of environmental issues contributing to climate change as well as negatively affecting human health. I ask that Cherwell Council representing the interests of all residents refuse this application.

I am writing to add my objection to other local residents in relation to the proposed Great Wolf Resorts complex in the nearby village of Chesterton, Oxfordshire. Despite our local Cherwell planning committee unanimously rejecting this resort proposal back in the Spring, we have been informed, as part of the local community, that the company has lodged a last-minute appeal on this decision.

There are so many reasons why this proposal was rejected in the first place, including its lack of accordance with the Local Development Plan, but I wanted to make sure my voice was added to other local people who will be unnecessarily and permanently affected by this proposed development. I would hope you are already aware of the many reasons for the objections, but I wanted to highlight a few in particular, that are pertinent to me and my village's proximity to Chesterton:

- Having lived in the village for over 16 years, we have already seen a major increase in traffic on our roads and back lanes due to the exponential growth of Bicester including the Outlet Village, which blocks all the roads in the vicinity every weekend; and the huge housing estates and the additional distribution warehouses etc., which are popping up across the town.
- There is also increased traffic from the redevelopment of the old US airbase at Upper Heyford, now featuring c. 700 houses, which will have on average two cars per household, making an increase of an additional 1,400 vehicles using our road infrastructure.
- At a time when exercising outdoors and spending time in nature have never been so important, grubbing up acres of nature-rich habitat, creating a substantial increase in light and noise pollution and building structures, which consider neither the site and significance of the area seem ludicrous. We are lucky to have diverse ecosystems in this area of Oxfordshire, with many wildlife corridors, ancient trees, and hedgerow habitats, all of which should be valued above an unnecessary and unsightly development.
- In reference to the community, there are already some big employers and a wide variety of jobs available in relation to other parts of the country, as well as a good selection of leisure facilities on offer, including the Bicester Golf Club and Spa, which offers the public a range of

reasonably priced memberships and day rates. This proposed complex will apparently offer nothing for the local community by way of utilising its facilities and anything that is offered sounds like it may be out of the price range for most members of the public.

• Finally, this is Oxfordshire, England. We have an incredible array of tourist attractions on offer from the historic city and Blenheim Palace, through to one of the biggest outlet malls in Europe and from some of the oldest oak trees in the world to the beauty of The Cotswolds. This is why people, especially Americans, visit our area in their millions. Tourists do not visit the county for an American-themed anything!

I trust my points above and the fact that I have taken the time to write to you on this matter, will contribute in some small way with everyone else's efforts in our community to ensure the final decision to this last-minute appeal by Great Wolf Resorts is rejection.

Dear Alison Dyson,

I am writing with concern regarding the great wolf's plans within our village.

There is also no benefit to local residents as the facilities offer no public amenity. The water park complex is designed for people who book overnight stays. Local day passes are extremely unlikely and expected to be expensive. Weekend passes are not available. It will also cause the loss of the golf club which is a key sporting facility also detailed under the Cherwell District Councils local development plan.

The plans seem to suggest a huge unsightly complex which will completely take over the landscaping of the village and would cause a massive treat to the wildlife. The scheme details an 84ft high water tower building which would absolutely destroy and not be in keeping with our village. This would be considerably taller than many buildings within London to put this in prospective and cannot be allowed to be constructed within Chesterton.

Looking at the proposals we are extremely concerned that it will have substantial implications in air and noise pollution and will absolutely destroy the wildlife habitat within the area and throughout our village.

The hotel detailed would be four storeys high with a capacity to accommodate around 2,000 visitors which would make the building one of the largest hotels outside of London. Potentially 500,000 visitors a year equating to 1,800 additional car trips a day on our local roads which are already very stretched to capacity. Heavy volumes of traffic would be travelling through our country lanes, A41,

A4030, B430, A4095, and the very concerning accident risk of the A34. This is extremely worrying as our children throughout the village use these roads to cycle on and families on a daily basis walking with dogs to get to and from the surrounding walks. Based on the construction details it seems to suggest a 2-year build program having around 2000 construction workers and approximately 31,000 delivers. This would equate to an average of 65 very large delivery lorries every day. Can you imagine the implications and danger this imposes onto the local residents and children throughout our village? This is a considerable risk and danger to the local community and in our opinion an accident waiting to happen.

It also seems to indicate a permanently floodlit carpark containing around 900 spaces, can you even start to imagine what this will look like within our village. This would be a similar capacity to the very large Westgate carpark in the middle of Oxfordshire. With the permanently illuminated carpark and size of the facilities it will look like an airport long stay carpark.

The plans detail an extremely large complex which to put into prospective would be 60 % larger than Bicester Village or the equivalent of two large Tesco's extra superstores. There is absolutely no way that this is in keeping or in accordance with the Cherwell Local development Plan.

To summarise as local residents, we are extremely concerned at the danger and treat this will impose onto us and an accident waiting to happen with the volume and continuous traffic for the construction initially and then the use of the facilities once completed. The proposed private complex and facilities pose a dramatic and extremely concerning threat to our countryside and our community life we thoroughly enjoy.

The above planning application is a speculative application for hugely disruptive building project which is not justified either a local or national level need. Further, it meets none of the requirements of Cherwell District Council's development plan. I write to object in the strongest possible terms **1 Location**

This is a totally unsuitable location for this project.

It is on the edge of the village of Chesterton and only two miles from the town of Bicester. The village identity of Chesterton is already under considerable pressure from new housing developments in the village itself, the encroachment of huge housing developments at Kingsmere on the west side of Bicester and the gradual ribbon development of ground on either side of the A41 on the west side of Bicester.

The site itself is currently a Greenfield rural area in use as a golf course but also a contiguous part of the surrounding countryside therefore an integral part of the ecological welfare of the area.

This obscene proposal to erect a water tower that is as high as our Queen's main residence, Buckingham Palace. A large floodlit car park and to tarmac over virtually the rest of the area is just unsustainable from any point of view.

2 Traffic

The proposed development will bring a huge increase in traffic volumes to an already overloaded area. The Cherwell local plan allows development only where public transport will be used for access. There is no public transport to this area. None.

The construction traffic will be detrimental to the environment and road infrastructure that is designed more for horse drawn vehicles than large cement trucks and 40 tonners.

The proposed development will encourage 1500+ daily traffic movements from all parts of the UK. This traffic will approach the area using the A34, the A40, the A41 or the A43. All of the highways already have major issues and must be considered barely fit for purpose with current traffic volumes.

Virtually all of this traffic will use the M40 either to Junction 9 or to Junction 10. Both of these junctions are inadequate for current traffic volumes. There is standing traffic on the M40 approaching J9 southbound and J10 northbound at peak times almost every day of the week and often for extended periods at other times.

The local roads, particularly around Chesterton, Weston-on-the-Green and Middleton Stoney are already heavily used as 'escape' routes from the congestion on local highways and it is totally unacceptable to propose significant extra traffic movements on to these routes.

3 Local Considerations

There is already considerable development in the Bicester area; what was a small market town with a population of less than 20,000 will become a much larger population centre approaching 60,000 over the next decade. There will be very little improvement in infrastructure to cope with this; as described above there are already huge traffic problems in the area.

Bicester already has to cope with the huge movements of employees and visitors to Bicester Village Retail park which brings large traffic influxes and parking problems to the area.

There will be little economic benefit to the local area from the proposed development . All visitors will be encouraged to remain on site for the duration of their visit and hotel rooms will not be available on a casual basis. There is little unemployment in the Bicester area, largely due to the success of Bicester Village which employs similar workers to those likely to be required by this development, and therefore the majority of employees would have to travel a significant distance by car to the site.

This development will entail the loss of a local sporting facility. As the local population increase more facilities such as this will be required. The current 18 hole golf course is a harmonious use of land which lies close to the M40 motorway for recreational purposes and also of local ecological benefit.

4 Health Issues

As just mentioned, this proposed development is for land which lies alongside the M40 motorway.

It is on the windward side of the motorway and lies just where the traffic is very often stationary because of the congestion at Junction 9. While this is acceptable for golfers who pass through the area in less than two hours I find it difficult to believe that children should be exposed to that level of pollution for periods of several days.

In conclusion I would suggest that this proposal is entirely unsustainable on grounds of location, lack of infrastructure and total lack of benefit to the area.

I write to object to this planning application.

As a resident of the nearby village of Bletchingdon for over 20 years I take a keen interest in the development of the local area. On the whole I think much of the development in this period has been proportionate, balancing the wishes of local communities with the national efforts to tackle the housing shortage and to encourage economic activity, amongst others.

However, I feel strongly that approving the Great Wolf Resorts planning application would be a retrograde step. My main concern is that it would seem to fly in the face of the environmental progress we all need to make in the coming years. For a start there is the conversion of the land into the resort which would negatively impact the local area and wildlife permanently. But more importantly, the operation of the site would generate significant unnecessary pollution, primarily because most visitors would almost certainly arrive and depart by private transport. And from how far would they come? Surely such a facility would be better situated nearer a major population centre on better public transport links? The local traffic situation is already prone to severe congestion on the A34 and major traffic incidents around junction 9 of the M40. Any project which is going to make this worse needs to justify itself thoroughly - which I doubt Great Wolf Resorts can do. For example, they will surely claim jobs will be created. And that is undeniable. But, on the whole, they will not be high value-added skilled jobs with the wages to match which the area should prioritise.

While my family and I will not be affected as much as the nearer residents - particularly those in Chesterton who I note are firmly against this planning application - I am very much against the proposal. Ultimately, I question why a private organisation from outside of the area should be given a licence to profit at the expense of local communities who will see a reduction in the quality of their environment.

I wish to strongly object to the above-mentioned application on the grounds that this proposal is not in accordance with the local development plan. There are no material considerations that would warrant planning permission being granted.

The proposed development is not in an appropriate place. It is on the edge of a small village and all access is via small country roads which are already significantly degraded and are much too small for a development on this scale.

The proposed 900 space car park indicates an expectation of significant reliance of staff and visitors using cars. The existing infrastructure cannot cope. The suggestion of signage to make cars avoid the village will not have any effect. People are well aware that satnav and Google are more effective.

Rat running through Chesterton, Weston on the Green and Wendlebury are already a significant issue and this application would add to this. The condition of some of these roads is already terrible. Additional car movements would also contribute to a further degradation of air quality.

The proposed site is a greenfield site. With the emphasis on caring for our planet, at the very least, it would be more ethical to find a brownfield site for a venture such as this.

Employment in the area is high. Inevitably, to attract staff it will be necessary for the applicant to employ people from out of the area increasing car use, or try and attract them from other local businesses so affecting local businesses in a negative way.

I am writing concerning the proposal to build a waterpark on the outskirts of Chesterton Village in Oxfordshire. This application has already been before the Planning Committee and was rejected both by all local Parish Councils and unanimously by Cherwell District Council who believe that this is completely unsuitable in this location.

The reasons for rejecting this proposal remain the same as before and are listed below:

- 1. It is proposed to build this on the Chesterton Golf Course which is a key sporting facility under Cherwell District Council's local development plan.
- 2. It will be a huge facility dominating our landscape with a four storey high hotel accommodating around 2000 guests, a 900 space multi-storey car park and a very high water tower.
- 3. It has been suggested that there will be around 500,000 visitors per year which are going to make a massive impact on our local community and our local country lanes which are already stretched to capacity as we are close to a major junction on the M40 and we have Bicester Village Shopping Centre nearby which is one of the most popular tourist attractions in the

country outside of London. It has been suggested that the traffic will increase by about 43% and will affect not only Chesterton but all the neighbouring villages as traffic will inevitably use all routes available both to get to the Water Park or to avoid the area if passing through.

- 4. All of this will cause a substantial increase in air and noise pollution and will destroy our wildlife habitat.
- 5. On a personal note it has been suggested that the value of our properties will decrease by approximately 10% which is for something that is of no benefit to ourselves as most of the visitors will be staying overnight in the hotel and day passes will be very limited for local people.
- 6. We are led to believe that the construction will take place over a two year period with a projection of approximately 2000 construction workers and 31000 deliveries. This alone will impact our roads.

To sum up this proposal is completely unsuitable for this area and cannot have been thought through properly. Bicester, as a whole, has grown immensely in the last twenty years with many new houses, shopping centres and industrial sites. The local roads have been improved to cover all this extra traffic but has certainly not been built to sustain the proposed amount of traffic that this Park will generate. Having lived here for thirty eight years I have seen this village grow beyond recognition and the noise pollution from the nearby M40 motorway has made a huge impact on all who live here. We are unable to take a walk around the village as the amount of traffic we already have makes it very unsafe. I urge you to look at these proposals and consider what the impact will be on all of us in the Bicester area. There must be other areas that are further away from an already busy area and would be more suitable for a project like this. It is not a case of "not in our backyard" as we have already had a huge amount of development in this area.

The existing road structure will not be able to cope with the projected 1000 daily car movements. Chesterton is already a rat run and experiences major congestion as an escape route during the many traffic issues on the A34 & M40

The proposed 500 room hotel will be a major drain on local services (water, sewage etc)

The loss of the sporting facility of the golf club which would be reduced to a nine hole course will mean the demise of the golf club. As a resident of Chesterton I write to request that you reject the appeal by Great Wolf Resorts to build a resort over the existing golf course on the edge of our small and historic Oxfordshire village. This resort will make an existing leisure facility unavailable to me, as a local resident, as well as being completely out of place and out of keeping with its surroundings. More concerning is the huge amount of additional traffic on surrounding unmarked, single carriageway and village roads that will inevitably arise as a result of the resort's target audience being 'stay and play' families. The vast majority of these will travel by private car, as anticipated by the huge car park which forms part of the plans.

There have been numerous news stories about drivers getting stuck in locations, such as fords, due to the modern propensity for following satnav instructions rather than road signs. As shown below, a simple check of Google maps identifies that the preferred satnav route for visitors travelling north to the resort from the M40 (from London and the south) will be via the unmarked road through Little Chesterton and onwards through Chesterton.

A similar check shows that the preferred satnav route for visitors travelling west to the resort, from the directions of Milton Keynes or Aylesbury, will be through Chesterton on routes that originate from the days of horse-drawn transport. The current danger to pedestrians, including primary school children, is already a major concern for residents of our village. The huge increase in traffic to and from the resort's planned location will only worsen existing problems.

On these grounds alone I request that the ill-selected location for this planning application be rejected. Regards

I must object in the strongest possible terms against the above mentioned appeal for the Wolf (PAW) proposed Resort Park. It has already been rejected on the basis of it being totally unsuitable for its planned location, by sound objections backed by local knowledge and experience.

As a resident in the local village of Wendlebury since 1986 I also believe I am well placed to support the objections as they will clearly impact all the residents living in Wendlebury village.

Flooding is now a major concern within the village that is now a regular occurrence at least twice a year (particularly flash flooding). Whereas previously the first flood in the village that I recall was some 15 / 16 years after I became a resident. The frequency and severity of the flooding is too much of a coincidence to be put down just to "Global Warming". Construction and development in and surrounding Bicester has gone on unabated and is well documented. The proposed site of the park will directly impact and affect the water courses and drainage gullies that subsequently flow through Little Chesterton and on into the Wendlebury brook via a culvert under the A41. This stream is the primary reason for any flooding within Wendlebury and the Environmental Agency have recognized and registered Wendlebury as a flood zone. This proposed development with hard surfaces of hotel, car parks and other facilities can only raise the flood risk to Wendlebury yet further.

The estimated 500,000 additional visitors a year with the additional vehicles will bring yet more traffic disruption to the area on a road network already having reached capacity. Furthermore the noise and air pollution will inevitably increase together with destruction to the wild life and habitat already under extreme pressure.

Therefore, as a local resident I support the rejection to this proposal that clearly conflicts and not in accordance with "Cherwell Local Development Plan" and hope common sense will finally prevail.

I encourage the Inspectorate to reach the correct and rational decision and reject the application to build a Great Wolf resort complex within the area of Cherwell Council.

I write from my home in rural West Sussex where I am conscious of the benefits of being able to find solace in the countryside and the comfort of living in a smaller community.

I bought my present house to escape the consequences of corporate development. Until three years ago, I lived on a through route to Goodwood Motor Racing Circuit and the other Goodwood amenities. The peace of that house was seriously eroded over the last ten years by the expansion from a couple of weekends' local traffic gridlock to monthly events, combined with now, three major four-day events per annum. More are in prospect. I sold that house to escape the noise and traffic.

The green space and peace of The South Downs has been severely negatively impacted by this commercial development. The community in which I lived has fragmented and I dare say that the health of those who remain has deteriorated as a direct result.

However, that loss of my tranquillity is as a pinprick compared to the prospect of having a resort on **Chesterton's** doorstep. I was able to enjoy peace between the periods of ear-deafening passing traffic and the associated jams and diversions in the vicinity. Chesterton residents are in prospect to suffer 365 days per year if the proposed development were to go ahead. Unlike my Lavant house (PO18 9AH) or my Chilgrove house (PO18 9HU) where much income generated from the Goodwood events was fed back into the community, clearly no such will occur with a US corporation.

Town dwellers or country dwellers need a green and peaceful place wherein to re-charge. The health benefits of green peacefulness are well-established. Your local residents may well work in the city but when they return home, they too, need some semblance of calm at the end of their working day.

My daughter and family live in Weston on the Green and will suffer as a direct result, if this development were to be approved. They are established there with school-age children who attend the Chesterton school. The young are *road-savvy*. But with the increased use of the road past their house as a *rat-run*, my fear for their safety grows. Their

suffering can be measured in many ways. Provided they survive the higher volume of speeding vehicles past their doorstep and remember their curb-drill, their mental health inevitably will suffer and would probably manifest itself sooner than other air-pollution related health issues. They, like other members of your small communities, will pay an unacceptable price for this greedy commerce. They need peace when they get home.

In summary, my objections to the application are as follows: -

Too vast a development within a small community

- Unacceptable and unavoidable construction traffic upheaval and air pollution
- Contradicts the Cherwell Strategic Plan
- Guest access will exacerbate congestion along the already almost constant A34 congestion
- Will accentuate the need for narrow lane *rat-run* access through the surrounding villages
- Contradicts all national and international green ambitions in that access can only be by car
- Infrastructure inadequate to sustain even the present concentration of residents' use let alone the arrival and departure every few days of c. 2000 guests
- Minimal benefit to local business or community with profits being repatriated to the US
- Desecration of yet another greenfield site
- Inevitable negative impact on water resource for the existing residents and businesses in the area
- Drainage issues exacerbated to this high water-table area to the general detriment of all and to the specific detriment of the local residents
- A floodlit 900 place car park will further accelerate the loss of wildlife habitat and further damage a possible future Dark Skies initiative -<u>darksky.org</u>

Objection to APP/C3105/W/20/3259189 - Great Wolf Resort

Following Cherwell District Council planners rejecting the initial application made by Great Wolf Resorts' for a large resort park and hotel in Chesterton, Oxfordshire, I am writing to you to express my strong views that the Great Wolf's subsequent appeal must be rejected.

To approve the development of such a large scale complex in the proposed location in the VILLAGE of Chesterton would be totally unsuitable for a number of reasons:

Traffic

The existing road infrastructure (and that of surrounding villages) could not cope with the estimate 43% increase in traffic volume, plus construction traffic estimates at 65 lorries per day for two years.

Little Chesterton clearly cannot be the access route for cars to the proposed resort. However the only available alternative routing plans are via already stressed routes through Middleton Stoney or Weston on the Green.

Weston on the Green is already a 'rat-run' and experiences high volumes of traffic as an escape route during the many existing traffic issues on M40 or A34.

The proposal would also increase traffic onto the A34 which already encounters significant traffic problems daily.

Specific traffic concerns for the Weston on the Green access route include:

Any visitor traffic coming North up the A34 will likely experience congestion on the A34 due to likely the check in / arrival times. At this point they will come off the A34 and enter Weston on the Green via Church Lane. Church Lane is narrow and has no pavement in parts, yet residents – including children – walk to the shop, church, village hall and playground. It is simply not safe to add additional traffic along this lane.

With all construction and visitor traffic being routed through Weston on the Green on the B430, this causes major additional hazards for local pedestrians walking to the other local village facilities including the local pubs and the Milkshed café.

Environmental

The proposal is unsustainable in an inappropriate location on the edge of a village. The development includes 900 car parking spaces with a predominant reliance on car travel which goes against the Cherwell Strategy of reducing car usage and the Government's Ten Point Plan for a Green Industrial Revolution.

Development on the greenfield site would irreversibly remove important green infrastructure and disrupt / destroy ecological habitats and wildlife.

The area is already classified as "seriously water stressed" by the Environment Agency. Yet the proposed development is of such a scale it would have an enormous impact on this already stressed resource. What impact would this have on water for the existing residents and businesses in the area?

Lack of sewage and drainage infrastructure which will contribute to the already high risk of flooding in the area. In fact there is more than a risk of flooding - flooding is a regular issue in Chesterton, especially Little Chesterton which is the most likely access route cars will take when following sat nav - regardless of the route recommended by the proposed resort.

Deterioration in air quality and noise pollution from construction, service and visitor vehicles. And in light pollution from the resort itself - potentially being a distraction to traffic on the M40.

Lack of local economic benefits

There are limited benefits to local businesses as Great Wolf resorts aims to keep all guests on site to use their restaurants, shops and facilities

This proposal is contrary to Cherwell's strategic aim of prioritising Knowledge Based business investment as a priority, thereby offering employment supporting the 'Knowledge Economy'.

In summary the proposal remains totally inappropriate for the rural location and the existing road networks and infrastructure.

Yours sincerely, Alice Simpson I would urge the inspectors to reject this appeal and uphold the unanimous rejection of the planning application by Cherwell District Council. I am a resident of Middleton Stoney.

- 1. Any projected traffic volumes from this development need to take account of the frequent problems at the M40-J9/A34 junction as the B430 link from Weston on the Green to the M40 J10 is used as by pass route to avoid J9 causing at times long tail backs at the Middleton Stoney Traffic Lights. We already see lengthy ques at busy times at this crossroads, including cars jumping the lights. Anyone can make the calculations work at quiet times.
- 2. The traffic calculations need to fully include recent press notices indicating a further 1000 houses, film studios and other commercial buildings for the Upper Heyford site, this will only serve to increase the traffic problems on the B430 an B4090, including routes to the A34 and Bicester/Aylesbury.
- 3. We have seen on national TV recently the affects of bad flood planning where developers have been allowed to disregard local concerns with resultant flooding and guess what the developer blames the river/local authority. What storm risk levels are they using, there are large amounts of roofed areas, roads and parking. Prior to my retirement at an airport project my colleagues were using 1 in 100 year storm plus 40% due to climate change. I understand that the site outflow passes through Wendlbury, the stream through the village floods the road at times, flood calcs need to be extended down to the Thames and include all other proposed construction projects and East West Expressway.
- 4. Any site lighting including decorative, signage and floodlighting should comply with light pollution directives regarding upward light and be turned OFF after 11.00pm except for essential security lighting. Have the designers taken full account of the nocturnal wildlife and Batts.
- 5. I also understand that this development proposal does not comply with the Cherwell Local Development Plan.

Please consider the above comments when reviewing this Appeal.

I write to strongly object to the appeal ref: APP/C3105/W/20/3259189

I have been a resident of Cherwell District Council for over 40 years and believe this proposal is completely inappropriate for the area. My reasons are as follows:

• The proposed development is not in accordance with the Cherwell Local Plan. It was considered that the proposal would not comply with Policy SLE3 of the CLPP1 which requires new tourism development to be located in sustainable locations. The location has poor access via B-roads and in an area of countryside, well away from the tourist attractions of Bicester.

• This will NOT be a public amenity – the water park complex is designed for people who book an overnight stay.

• It is expected to attract 500,000 visitors a year, meaning increased traffic on our local roads, which are already stretched to capacity. This includes local country lanes, the accident hot-spot A34, plus the A41, A4095, B430 and A4030.

• It will add no value to the local community – visitors will visit for the on-site amenities so the surrounding area will not see an economic uplift to compare with the imposition of the project.

• The hotel – four storeys and with a total capacity of around 2,000 visitors – is grossly oversized for the surrounding countryside. This will be 60% larger than Bicester Village, which itself is the largest non-residential development in Cherwell.

• A permanently floodlit 900 space car park is wholly inappropriate and will damage local wildlife. Weston-on-the-Green is a "dark" village with no streetlighting.

• An 84ft high water tower building (potentially the tallest building in Cherwell is wholly inappropriate

• It will cause a substantial increase in air/noise pollution and destruction of wildlife habitat. I am deeply concerned by the impact on wildlife, air pollution, green spaces and the preservation of village life which will be greatly impacted by this development.

Great Lakes Ltd: Redevelopment to provide New Hotel and Leisure Resort Chesterton Bicester

I am writing as a long standing member of Bicester Golf Hotel & Spa to strongly object to the above lodged Appeal. Not only will the development significantly reduce the golf course by 50% but also completely overwhelm the present hotel facility with an unsympathetic and visually dominant development.

Whilst an expansion of the existing facilities would be understandable and sustainable in the light of the huge expansion of Bicester Town, the sheer scale of the proposed hotel and associated facilities is out of all proportion to adopted Local Planning Authority and/or National policies.

The proposed facility will not be open to local people on a daily basis – as it will be operated as a destination resort, so little or no local benefit will accrue to local area residents. Despite this the proposed development is likely to generate over 2000 daily vehicle movements plus service vehicles – which will all be directed onto minor roads and through small local villages.

Perhaps the most significant objection, notwithstanding the sheer scale of the development, is how unlikely it is that such a huge facility could possibly reflect or comply with anticipated Government Policies on climate change. At a time when carbon emissions are being driven down how would it be possible to justify the energy consumption/loss of such a gigantic facility?

At a time when a large leisure complex - only 20 miles away in Swindon, has announced that it will close later this year after a review of the centre's operation with landlord Seven Capital had concluded that it was "not viable". The proposed major development at Chesterton cannot be sustainable. Furthermore, one of the developer's resorts in the USA has closed, as a leisure facility – currently housing 500 Navy recruits.

With regard to the submitted plans, it is evident that this American styled and conceived building form is totally out of scale and inappropriate in a rural setting, located as it would be in Open Countryside. The building form represents the lowest common denominator of building form – conforming to a `pile it high sell it cheap' methodology, its appearance is ugly and insensitive.

In conclusion, the proposed development would seriously blight a large area of North Oxfordshire countryside, create immense traffic problems and cannot surely comply with adopted policies of the Local Planning Authority or NPPF. I trust that you will conclude that this appeal should be dismissed.

As a resident of Middleton Stoney I'm writing to object again to the proposed Great Lakes development in Chesterton, Oxfordshire. I live on the Ardley road, in Middleton Stoney, some 2 miles from where the proposed development would take place. We already see a significant number of vehicles passing by our front door, some 35,000 per week. Up the road in Upper Heyford a new development has been signed off which allows for 7000 new residents and is estimated to increase the existing traffic by 25%. OCC has already confirmed that there is 'severe congestion' within Middleton Stoney. Should the development go ahead the additional traffic would only compound the congestion and associated pollution with the number of building movements followed by visitor movements.

The proposed development does nothing of any benefit for the local residents of the villages surrounding and does much to decrease the existing standard of life in what is a pretty and rural area of Oxfordshire. The resort is entirely out of keeping with the surrounding area and would be a blot on the landscape. It offers very few employment prospects other than a small number of low skilled jobs. From the North American experience fewer than 5% of people visiting ever leave the resort to visit other local attractions which means there won't be any other revenue passing into the area.

I strongly urge you to reject the proposal in line with the unanimous Cherwell DC position the last time the planning proposal was made and avoid a total disaster for the local villages around the site of the proposed development.

To my previous objections to the proposal by an American firm to make money for itself by devastating an English village and a large area around it, I would like to add a few more comments.

The pandemic has made the nation vividly aware of the importance to both mental and physical health of green spaces, quiet places, and somewhere to walk in the fresh air. This has now become widely recognised. The golf course is important for all of these reasons, besides providing a means of exercise which remains available to people well into old age.

We have also become much more aware since this project was first mooted of the damage to health created by the internal combustion engine. The amount of traffic which would be generated, not only in Chesterton but also in the surrounding villages, by this scheme would bring both noise pollution and harm from air pollution to an area which already has too much traffic through village streets. This is not the only way in which this scheme would make it hard for the government's climate change aims to succeed, since the resort itself would generate demands on energy of the sort we need to diminish. The noise and unpleasantness of a constant flow of cars through village streets is stressful for those who live in them; mental health has become a high priority of late, as people are beginning to realise that the way our civilisation lives needs to change.

Saving the world does not mean just reducing emissions; it also requires positive steps to encourage wildlife to regenerate. Loss of habitat has become a serious problem for the natural world – without which we ourselves will be in trouble. The younger generation, who will suffer most from what we are doing to the world, have become particularly aware of the situation and passionate about it. Covering open space with buildings is bad enough; the effect on wildlife of all-night lighting on a large scale should also be considered.

All in all, where vast projects of this kind are concerned, the tide of public opinion has turned against them, a change which the pandemic has accelerated. The Wolf project is yesterday's thinking; it is the sort of thing that has created for our society too many of the troubles we now have to wrestle with. It is urgent that it is turned down.

We are writing to strongly object to the proposal to build a Great Wolf Resort in the village of Chesterton.

Our primary objection is that the proposed complex is not in accordance with the Cherwell Local Development Plan and to grant permission, following unanimous rejection of the plans by Cherwell, would undermine a planning system which, when allied to the Mid Cherwell Neighbourhood Plan, is currently highly regarded and respected.

It is vital that citizens in the UK can rely on the planning system which has been carefully developed over many years to manage development in a sensitive way, protecting the local environment rather than feel that the system can be 'bucked' by the introduction of vast capital resources which are designed to change the entire character of the area to one that is inappropriate and wholly unwelcome. To allow such an appeal would do precisely that.

If the proposal went ahead, it would dramatically change the environment of Chesterton and its environs. It would destroy the village atmosphere, increase local air pollution levels from traffic visiting the resort and increase light pollution from the buildings and car park. There would be almost no benefits to the residents of Chesterton or neighbouring villages.

I was born in nearby Bicester in 1965 and have a lived experience of how the area has developed over the past few decades. Bicester is unrecognisable from the small, attractive market town which I knew as a child.

I've watched with genuine alarm (and distress) how the area has been targeted as a growth area. So far, though, none of the surrounding villages have been swallowed up. Chesterton is still a pretty village with Cotswold stone houses - it's worth preserving and safeguarding. It has a strong community and a very separate identity from Bicester.

I feel that Bicester needs to have a boundary beyond which development of this kind isn't permitted. This is my second letter in regard to this application,

To reiterate my previous conviction that this proposed development would be extremely damaging to the area of the site and large number of the surrounding villages, I would like to repeat as follows:

Cherwell District Council unanimously rejected the planning application from Great Wolf Resorts to build a super-sized American Water Park with a 2,000-capacity hotel in the Oxfordshire village of Chesterton, **as being completely unsuitable for its location.**

Do we need for a development of this kind? It would be a different story possibly if we **needed** a hospital or a **school**. The proposed private complex was huge and unsightly, dominating the landscape. Its footprint would be 60 per cent bigger than Bicester Village or equivalent to 2 Tesco superstores, with a permanently flood-lit car park for 900 cars. The hotel alone would be one of the largest outside London - four-storeys high with 500 family rooms and a capacity of around 2,000 visitors daily. Can we say genuinely that there is a need?

GWR aims to attract half a million visitors a year, mostly travelling in private cars, making 1,800 additional car trips a day on local roads already stretched to capacity. This would include not only country lanes, the A41, A4095, A4030 and B430 but also the accident hot-spot of the A34, and would significantly increase greenhouse gas emissions which would not be in line with any climate targets set by the Government. The Paris Agreement 2015 is government policy on climate change which as a matter of law must be taken into account in any decision.

The expansion of the golf course would adversely affect the flora and fauna of the site and we have seen no evidence that the environmental impact of the scheme has been assessed properly and robustly and all of this for some questionable economic benefit, because the proposed resort is not a local facility as I mentioned in my previous letter because there will be little or no 'trickle down' benefit to local businesses as customers will stay at the hotel and use bars, shops, restaurants on site. There are currently very low unemployment levels in the types of jobs to be offered by GW (bar staff, cleaners, waiters) Many restaurants and pubs already struggle to fill these vacancies already so competition with the Great Wolf Lodge will make staffing issues even more problematic.

In closing I submit my complete and total opposition to this application.

I am writing concerning the proposal to build a waterpark on the outskirts of Chesterton Village in Oxfordshire. This application has already been before the Planning Committee and was rejected both by all local Parish Councils and unanimously by Cherwell District Council who believe that this is completely unsuitable in this location.

The reasons for rejecting this proposal remain the same as before and are listed below:

- 1. It is proposed to build this on the Chesterton Golf Course which is a key sporting facility under Cherwell District Council's local development plan.
- 2. It will be a huge facility dominating our landscape with a four storey high hotel accommodating around 2000 guests, a 900 space multi-storey car park and a very high water tower.
- 3. It has been suggested that there will be around 500,000 visitors per year which are going to make a massive impact on our local community and our local country lanes which are already stretched to capacity as we are close to a major junction on the M40 and we have Bicester Village Shopping Centre nearby which is one of the most popular tourist attractions in the country outside of London. It has been suggested that the traffic will increase by about 43% and will affect not only Chesterton but all the neighbouring villages as traffic will inevitably use all routes available both to get to the Water Park or to avoid the area if passing through.
- 4. All of this will cause a substantial increase in air and noise pollution and will destroy our wildlife habitat.

- 5. On a personal note it has been suggested that the value of our properties will decrease by approximately 10% which is for something that is of no benefit to ourselves as most of the visitors will be staying overnight in the hotel and day passes will be very limited for local people.
- 6. We are led to believe that the construction will take place over a two year period with a projection of approximately 2000 construction workers and 31000 deliveries. This alone will impact our roads.

To sum up this proposal is completely unsuitable for this area and cannot have been thought through properly. Bicester, as a whole, has grown immensely in the last twenty years with many new houses, shopping centres and industrial sites. The local roads have been improved to cover all this extra traffic but has certainly not been built to sustain the proposed amount of traffic that this Park will generate. Having lived here for thirty eight years I have seen this village grow beyond recognition and the noise pollution from the nearby M40 motorway has made a huge impact on all who live here. We are unable to take a walk around the village as the amount of traffic we already have makes it very unsafe. I urge you to look at these proposals and consider what the impact will be on all of us in the Bicester area. There must be other areas that are further away from an already busy area and would be more suitable for a project like this. It is not a case of "not in our backyard" as we have already had a huge amount of development in this area.

In March the councillors at Cherwell District Council unanimously voted on six counts to reject the planning proposal by Great Wolf Resorts to build a massive hotel and indoor water park for young families in a rural part of North Oxfordshire. I am completely shocked that this has gone to appeal given the depth of feeling in the whole area and beyond against this unnecessary development.

The size and design of the resort is totally unsustainable for the proposed location, having a negative impact on local infrastructure, rural landscape, traffic and local communities. It would be a disaster for the region, not to mention the affect on water supplies and drainage, which are already at a stress point in the area. This project is purely for individual and corporate profitable gain with lack of regard for long term development of the area and overall community needs.

The claims for an economic benefit to the area are completely unfounded, trying to exploit on the short term instability of the economy due to Covid 19, which is totally immoral at such a tragic time for many countries. I am writing to ask you to please defend our rural village and its lovely surrounding areas, and to defend the position taken by Cherwell District Council when they unanimously rejected the planning application by Great Lakes UK (Great Wolf Lodges) earlier this year to erect a super-sized warehouse-style resort on the edge of Chesterton.

This type of facility is simply not needed, it is not in the local plan, it is not a leisure facility to be enjoyed by the locals and will bring them nothing but noise, flooding, and unnecessary and unwanted traffic.

Chesterton is an idyllic country village, with a picturesque and popular pub just opposite the church with the village green in between. This proposal will bring an additional 1800 cars PER DAY through the village, which has a school on the only road through it. There is already such an issue with traffic at school pick up and drop off times that the Parish Council have recently been considering double yellow lines near the school.

You might say that designated signs to direct visitors to the resort away from the village might be adequate, however, these days everyone simply types a postcode into their Sat Nav and follows that - if the traffic is building up in one direction, the traffic will be sent through another village or through a tiny residential road that is unable to cope with such a throughput. One of the routes Sat Nav currently brings cars to Chesterton from London is through Little Chesterton - a single track road. Current infrastructure cannot handle the additional traffi and the added load will wreak havoc upon local residents and businesses alike. Any possible future planning to widen roads to accommodate the additional visitors to the area would make a bad matter that much worse, not only ruining the village of Chesterton, but also its surrounding areas. Simply put, the proposed facility is unsustainable and bringing this type of resort to a small village is not a good idea, nor is it in the best interest of the community.

Great Wolf Resorts are usually housed on the edges of cities, not in a rural environment and it would appear that as this is their first location outside North America, they are trying to buy cheaper rural land to escape more expensive urban land prices. Quite simply, this does not fit here.

Several homes in Chesterton flooded this year and in Little Chesterton there are ongoing drainage issues - an enormous complex with a car park for 900 cars will in no way help the current, already worrying, situation.

Indeed the ecological impact of this build would be nothing less than catastrophic - building over a popular golf course, with acres of rough ground supporting a huge variety of wildlife is not in line with the current government requirements to increase the biodiversity of each new build by 10%.

Please do not allow this misfitting, damaging build to take place.

This Planning Application is unnecessary, unwanted and has already been refused. When before the Cherwell

District Council Planning Committee earlier this year it was unanimously rejected for very sound and well

argued reasons. The GWR appeal addresses none of the rejection reasoning but merely says they do

not accept that decision. Their appeal was submitted at the last minute and offers nothing new.

The additional traffic and destruction of a much needed 18 hole golf course would have a significant and

permanent detrimental effect upon the local community and golf players. To suggest a 9 hole course with

9 additional tees is totally unacceptable alternative to the golfing community. It also comes about when three

golf courses in this area have, or will soon be closed in under 2 years.

The additional 500,000 proposed visitors will bring chaos to an already inadequate local traffic plan.

It is also contrary to the Local Plan for the District and would come on top of major housing developments

in this area. These and several other reasons that were well set out when the GWR application was rejected.

There are no actual benefits to the local community and if granted would cause great harm. Usage of the facility

is not for locals as its prime use is for GWR hotel guests staying for 2/3 days. Only a few day tickets will be

I am writing to request that you **reject** the appeal by made by Great Lakes UK Ltd against the decision of Cherwell District Council to refuse planning permission for the proposed development of land to the east of M40 and south of A4095, Chesterton, Bicester Planning application REF. 19/02550/F.

I am not a resident of Chesterton, but of the new Kingsmere residential development on the outskirts of Bicester. My children do attend school in Chesterton. The reasons why I believe you should reject the appeal are as follows.

The Appellant state 'The Appeal Site has been chosen because of its strategic location on the M40 giving ready access' but have no plans to link the site directly to the M40 or significantly improve local infrastructure to support the increased traffic it will create. No matter what routes are planned for the consumers, the consumers will follow their SatNav's and I believe this will have major implications on Junction 9 of the M40, the A41 leading towards Bicester and Vendee Drive directly past the new Kingsmere development. These roads are already under great strain due to the nearby visitor destination Bicester Village. This is before the consumers then enter the village of Chesterton. Any other routes to the proposed location would adversely affect other surrounding villages. Please note there is currently no safe route for me to walk or cycle the relatively short distance with my children to school between Kingsmere and Chesterton, so I have no option to use 'other means' other than my private car to access a site closer than that proposed by Great Wolf for it's 'local' work force.

This goes against points 5 and 9 in the recently released Governments 10 point plan for a Green industrial revolution.(<u>https://www.gov.uk/government/publications/the-ten-point-plan-for-a-green-industrial-revolution/title?</u>

fbclid=IwAR09KII7Gx3mJkUoBc3eosSdH8DXeeO Fvt0Imd4etharLU FII3SGumSYY)

The Appellant state they are a 'destination' leisure resort, similar to Center Parcs, Warner Leisure Hotels etc. These types of resorts inevitably serve wider national catchments, yet no detailed road improvements are offered to serve the arrival and departure of this national consumer.

The Appellant state 'the location of the Appeal Site close to the rapidly expanding settlement of Bicester (which it will serve) with the very good rail services at Bicester offering genuine alternative transport options'. There are currently no public transport links between the Village of Chesterton and Bicester town, let alone the railway stations. It is also my understanding that as a destination resort day passes for local residents will be over-priced if they are available at all, so the resort will not serve the local community.

Furthermore, it is my understanding that the resort could put great strain on the local water resources when the area is already classified as "seriously water stressed" by the Environment Agency.

The Appellant state 'sustainability benefits including easy access to a local workforce and supply chains that can access the site by means other than the private car.' As I have already stated there are currently no public transport links to the site and when do supply chains use other means than public highways to deliver to their suppliers? When referring to local workforce I would like to point out that there is currently a shortage of construction workers in and around the area.

In summary I believe that the location is not suitable for the development, its impact would be far more detrimental than beneficial to both the immediate local community and the wider surrounding communities especially on environmental grounds. I believe this has already been shown by the original 820 letters of objection received by CDC during the original application process and CDC's unanimously rejection on six different counts, back in March by CDC.

Thank you for taking the time to read and consider my objections and I urge you to please reject this application.

I am writing to express my objection to the Great Wolf Resorts proposed development at Chesterton on 9 holes of the Bicester Golf Course. I have been a member of the Golf Club for many years and have many friends who live in the local area. My key objections are:

Great Wolf Waterpark Size - Chesterton is a lovely small historic village, whilst conveniently located close to Bicester and Oxford. The mass of the Great Wolf Hotel, Water Park and 900 space carpark is totally out of context with the village environment and does not respect the character of the countryside. It will dominate the village and detract from the amenity and character of the village, and I think it will also affect the amenity and character of villages in the corridor between Oxford and Bicester south of the B430.

Does not benefit local business community – While the waterpark may create jobs in the hotel and leisure sector, the business model is a self-contained resort were people do not leave the site, so there will be little if any benefit to other businesses in the area.

Increased traffic – The projection of 500,000 visitors a year will increase traffic in the area, not only on the A34, A41, A4095, B430 and A4030 but also on local country lanes. Having recently been in a car accident on the B430 myself I know how dangerous the roads can be and increased traffic will only increase the risk of accidents.

Environment and changing climate – A waterpark seems to be an inappropriate development in a time of climate crisis. It will be calling on increased demands for energy resources including water which is a limited resource in Cherwell, and increase waste emissions at a time when we should be thinking of ways to preserve resources and decrease emissions. Also once built it cannot be reversed.

Preservation of Green spaces near Bicester and the protection of bio-diversity – There are public access paths through the golf course presently used for walks and recreation by Chesterton residents and others. The plan preserves a small amount of green space, which will be used by visitors to the waterpark not local residents, and will be a small isolated triangle sandwiched between a massive hotel, a covered waterpark, a car park and the M40. Covering a 9 hole golf course with concrete detracts from rather than enhances the biodiversity of the area.

Golf – The Bicester Golf Club is a challenging 18 hole course for the keen golfer, only 5 km from Bicester Centre, and as such should be considered an asset to the area, and should be fostered and

preserved rather than carved up. The argument put forward by Great Wolf that 18 holes could be squeezed on the remaining 9 hole golf course is misleading. The planning application does not include this provision, and any reconfigured course could not replace the existing provision.

As consultees for the original planning application we were concerned about the absence of the final report on the archaeological evaluation and the lack of a desk based environment assessment. These were in fact submitted after our objections had been lodged. Although they address our concerns we believe that the evaluation trenches, as illustrated in Figure 2 of the Archaeological Evaluation Report, should have also included the area to the south and north of the area studied in order to obtain a total understanding of the whole site. Although no finds of note were found, the proximity of the site to the Roman road of Akeman Street which runs several metres to the south increases the likelihood of finding items of archaeological interest in that area.

Our other major concern is that the development will have a major deleterious effect on the rural setting of Chesterton. The size of the development is out of all proportion to the countryside setting of the village and will be highly intrusive. The building and the associated facilities will be incongruous to the vernacular architecture of Chesterton village.

There are major environmental concerns bearing in mind the large area being covered in concrete and hard standing , thus destroying valuable habitats for plants and animals. This is not a brownfield site – it is precious agricultural land.

We feel that neither the people of Chesterton nor of Bicester will gain anything from this development, financially or as a leisure facility.

We hope, for the sake of Chesterton residents, that this development is not allowed to go ahead.

It is with great concern that we write to you today. We understand that the above Company are appealing against Cherwell District Council's rejection of their Application to create in a completely rural and village environment an enormous Pleasure Park including a huge hotel and many entertainment attractions, and will include an 84 foot high water tower and huge 900 car capacity car park.

We are supporting CDC's rejection on several counts. This development is completely out of character for this small village environment. Its enormous (four storeys high) hotel would be very near a brand new hotel which has just been built on the A34 which will cater for many guests. The situation was part of a popular golf course which has been virtually cut in two. The amount of through traffic and country road use would not be sensible, safe or suitable and to enlarge these to cater for heavy goods vehicles whilst construction takes place (together with removal of hedgerows, trees and natural beauty) would destroy the village character of Chesterton. Tourist traffic and any extra visiting vehicles passing through and around the area would cause problems with an already overloaded road system in the area, coping with much use of the Bicester Village facility as well as causing acute anxiety to its current residents who would have to cope with constant lighting at night, noise and disruption. Naturally we are deeply concerned about the environment, the countryside and wildlife of the area. We have a diverse flora and fauna which needs protection and the intrusion of so much commercialism in this place would be detrimental to sustaining these; the increase in traffic, noise, light and air pollution would be great and, as mentioned above, this is a small rural village which already has more through traffic using the surrounding feeder roads to reach Bicester Village. Impact from traffic would naturally affect other nearby villages too, and it is estimated that it could mean as much as 1,800 additional vehicles using our already heavily congested local roads.

We understand also that this proposition would not necessarily benefit the local population since much of the proposed use would be by booking for overnight stay and local passes would likely be scarce and expensive. With an estimated 500,000 visitors annually this will put an enormous amount of pressure on the local area.

We would ask that the Inspector will uphold Cherwell District Council's refusal to allow this development.

Charlton On Otmoor is a small village about 3 miles (5km) due south of Chesterton. Like Chesterton it is one of the many villages and communities that are a vital part of the rural character of Oxfordshire. The pandemic has illustrated how vital green spaces and countryside is to the mental and physical well being of the residents of the county.

Charlton On Otmoor Parish Council fully supports the opposition to the proposed development by Chesterton and other villages and its rejection by Cherwell District Council.

The site is currently a golf course with many areas of land, adjacent to greens and fairways, which are beneficial to wildlife. A large proportion of this valuable amenity will be lost if the development goes ahead. It is impossible to claim that there will be a 30% net gain in biodiversity when well over 50% of the site is going to be turned from managed grassland, rough grassland, scrub and woodland to large buildings and hard parking areas.

The development will change the rural character of the area with the visual intrusion of the buildings and the artificial illumination of the development. Even allowing for the noise from the adjoining M40 this development will have a significant impact on the rural tranquillity of the area.
