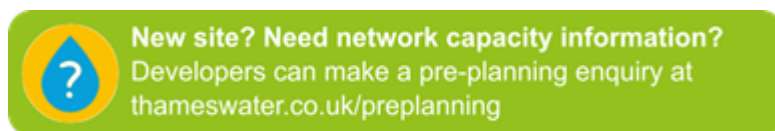
We are keen to work with the developer so would be happy to liaise with them directly if you are able to provide details of the best point of contact.
