#### **VARIATION OF CONDITIONS FOR PLANNING PERMISSION 18/01333/F**

We write to submit information for the variation of conditions attached to planning permission 18/01333/F. The application was for the extension to existing Technical Site to provide new employment units comprising flexible B1(c) light industrial, B2 (general industrial), B8 (storage or distribution) uses with ancillary offices, storage, display and sales, together with associated access, parking and landscaping. The application to vary the conditions has been made via the planning portal under reference PP-08147840.

#### Condition 2 - Approved Plans

A number of changes to approved plans are required to deliver the proposed buildings. The changes include minor alterations to the fenestration of the buildings. These have been assessed by our design and consultant team and make overall improvements to the aesthetics of the scheme and benefits to occupiers.
