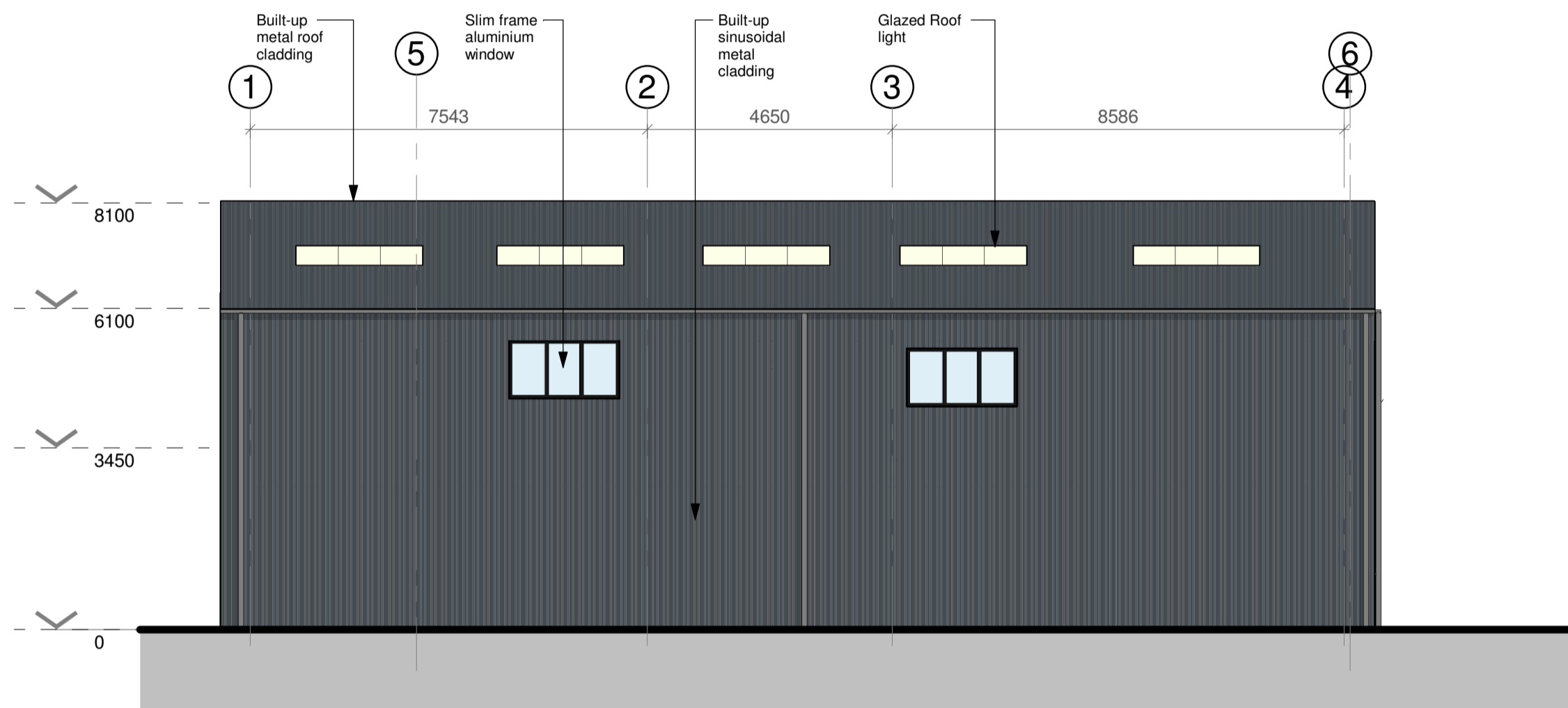
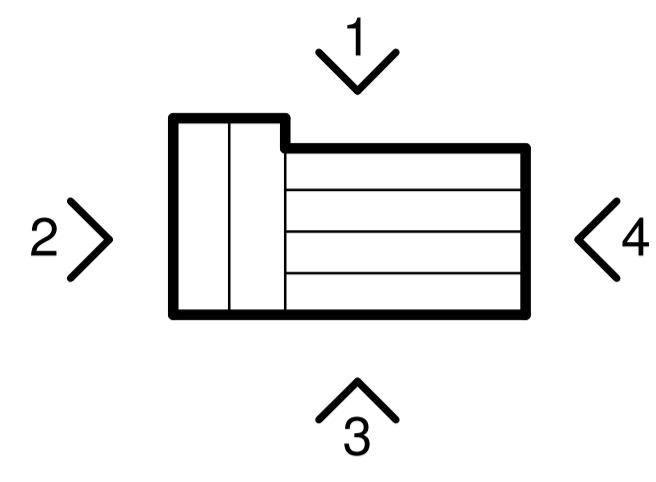
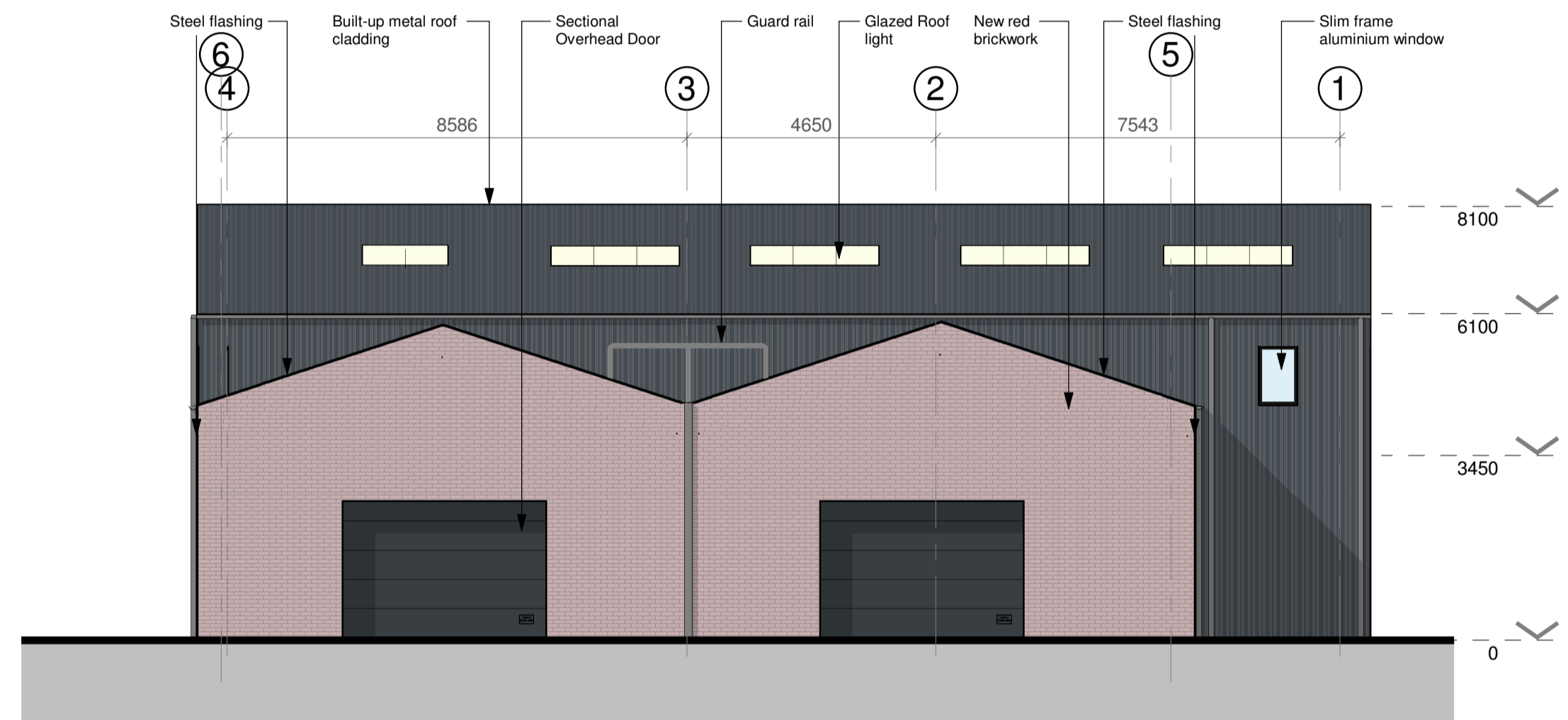


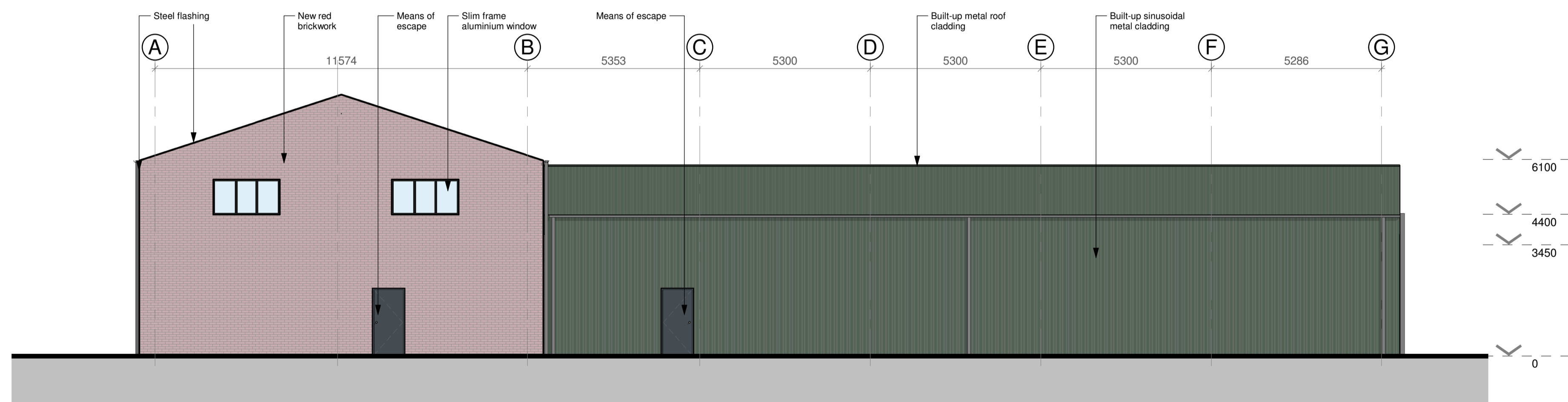
1. North-East Elevation

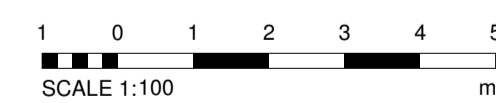


4. South-East Elevation

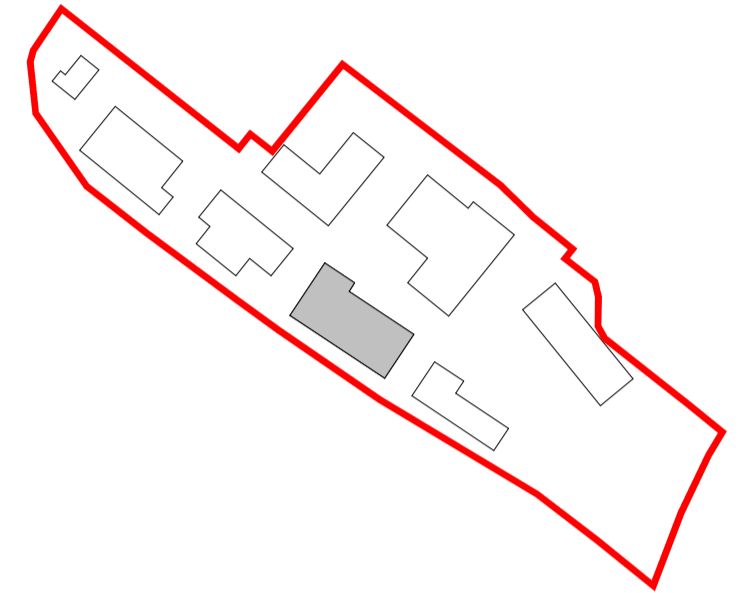
