Planning application Ref: 19/02337/F – demolition of Building 457 southern façade and gable end walls etc. was discussed by Heyford Parish Council at its monthly meeting.

The Parish council **OBJECTS** to this application.

The garden is well designed but it replaces an approved (and existing) building which is a much needed amenity for the community

The developer had assured the community that they will deliver this area which comprises of the two buildings joined via a canopy link for a covered market. It's vital that this is delivered and that the developers should build what has been approved together.

With the increase in housing the developers should not be reducing amenities such as this.

It is feared that this temporary garden will become a permanent feature instead of the planned building for the Bar/Brasserie and this could set a precedent for future plans.

The council also supports Historic England's reasons for objection.
