Thanks for getting back to me on that.

Just to confirm then, are you happy for me to amend the application for:

- 3 Skimmingdish lane – amend to T20, 21, 27-31. Re reduce to previous reduction points/reduce by up to 1.5m
- 1 Barnfield close – T4-17 re reduce to previous reduction points/reduce by up to 1.5m
- 8 Skimmingdish lane – appreciate it is close to the property, however if a lesser reduction is possible it would preserve the trees amenity considerably. Amend to reduce by 2.5M.

Are you happy with all the above amendments? All other applications from this site raised no concerns from our surveyor.

Hi Christian,

Regarding your tree works in conservation area application, our surveyor has raised some concerns.

T4-17 – the trees appear to have put on 1-1.5m of growth following their last reduction. The application proposes a reduction to previous points, however gives 2-3m as an amount. Could you confirm please is it to previous points, or 2-3m?

Trees 20, 21, 27-31 have been recognised as large, healthy well formed trees, again having only put on 1-1.5m of growth following their last reduction. We are concerned for the size of proposed reductions (3/4M) and feel this would significantly alter their contribution to the conservation area.

I appreciate some of the trees require reductions due to their location, however feel a more moderate reduction would be more appropriate. Would you be open to discussing and amending the application in order to avoid refusal/TPOs being placed?
