Please accept this email as a vigorous objection to Great Wolf Resorts' application to build a water park in Chesterton. The project would decimate human and animal life in what is, and has a right to remain, a peaceful rural area. As well as disfiguring the countryside and disrupting daily existence, the construction and running of a resort like this would funnel untold amounts of traffic into an area that is simply not equipped to handle it.

Coming on top of already dense development in the surrounding area (Kingsmere, Upper Heyford etc), the scheme will compound congestion and pollution while making a mockery of the Council's claim to care about climate change. With its vast carpark built on green land and an eyesore of a water tower, the park has nothing to offer locals residents (of surrounding villages as well as Chesterton itself) apart from ecological damage and a reduced quality of life. It seems to me that the impact of the initiative has not been thought through by Great Wolf. I hope, by contrast, that the Council does indeed understand the damage the park will inflict, with little in the way of compensating benefits, and respectfully request that members reject the application.
