

# Comment for planning application 19/02708/OUT

<b>Comments</b>	<p>Whilst I applaud the expansion of the Bicester Reserve in the north section of the Airfield and adding in Native Trees around the perimeter, I do not agree with removing the existing vegetation and restoring the sight line. This will take away a lot of the noise damping which currently exists. I think they've already removed enough vegetation on Skimmingdish Lane to build all those buildings. This sight is historically and Airfield and used extensively by the Bicester Flying Club and has been there for a very long time. It is peaceful to see the Gliders flying overhead. There is currently very little noise from the Airfield. With the proposed plan to turn this into one of the "Top 20 Tourist Attractions in the UK": 1) The road infrastructure won't support it 2) I don't want to have to fight traffic congestion every weekend/weekdays just to go shopping down the road 3) I don't want the air pollution which will ensue from cars queuing to get into the Airfield from frequent events 4) I don't want the added noise of a race track on the Airfield - Caversfield is a peaceful place to live and I don't want that peace disturbed 5) With the visitor numbers increase, this will have an extremely adverse affect on the wildlife which currently inhabits the Airfield 6) We are in the midst of a CLIMATE EMERGENCY!!! we do not need to add more pollution from increased car fumes and people travelling to and from events. We are trying to SAVE THE PLANET!!! not increase our human burden on it 7) The rubbish on the streets around the Airfield is already bad enough. We do not want our streets to turn into a rubbish tip where people attending the additional events see fit to just empty the rubbish out of their cars whilst waiting to get onto the Airfield 8) A lot of the Wildlife which inhabits this Airfield will be forced to relocate to safer areas to bring up their families as with increased visitor numbers also comes increased "Pet Pollution" and dogs chasing the Wildlife there which will stress them out and could cause whole generations of endangered species such as Yellow Hammers to be lost. Their numbers have already decreased dramatically since the 1970s. The Airfield will then also be covered in dog poo and baby's nappies 9) The most significant thing about the site currently is that it is: ONE OF THE LAST OMNI DIRECTIONAL GRASS FLYING FIELDS IN THE COUNTRY STILL IN USE! This is a very IMPORTANT part of BICESTER's HERITAGE! This will be lost forever if Bicester Motion have their way 10) The Gliding Club attracts people from all around the surrounding Counties who come to fly there 11) There is a children's playing field on the Caversfield side of the A4421, with the added stationary traffic, this will blow petrol/diesel fumes across this playing field and make it toxic for kids to play there 12) There are also 2 Nursing Homes, one on either side of the Airfield. Old folk want peace and tranquility, not constant noise pollution from additional events on the Airfield 13) What are all these "Motor Vaults" being built along the far boundary? How far underground will they go? 14) If this should go ahead, then soon additional Cafe's/a Hotel/Shops/Houses will also be built on current "GREEN FIELD SITES" and the beautiful Countryside around Bicester will be lost. We already have lost enough "GREEN FIELD SITES" around Bicester with all the new houses being built at the M40 end of the A4095 and the new Business Park there 15) It is already really difficult to get out of Skimmingdish Lane onto the A4421, with the additional traffic - it will become impossible 16) It is already difficult enough to get out of the Fringford Road onto the A4095, with the additional traffic - it will become impossible 17) There are already big queues along the B4100 to get onto the A4095 and into Bicester - we don't need any more. 18) It is already difficult enough to get out of Aunty Ms Lane onto the B4100, with additional traffic - it will become impossible 19) The roads cannot cope with the additional traffic and any widening etc would have an adverse affect not only on the biodiversity of the area but also add to AIR POLLUTION and GREEN HOUSE GASES. 20) WE WANT TO SAVE THE PLANET - NOT KILL IT FASTER I therefore OBJECT to these new plans for the Airfield. I may add more at a later time as I thinks of other points.</p>
