4. RESPONSE TO CONSULTATION

4.1 Ecology Officer: Initial comments raised concerns regarding the impact of the lights of ecology. The applicant responded by submitting details of operating hours and reduced lux levels.

The final comments received from the Ecology Officer stated: 'This additional adjustment in wattage would be beneficial and in general I would find this acceptable given that the lighting will be off for much of the bats foraging hours'.

5. APPRAISAL

5.1. Condition 10 – The proposal for the boundary treatment includes re-using and repairing existing fencing. The existing fencing is green, metal, industrial style fencing. It covers the perimeter of the new technical site and most of the perimeter of the wider Bicester Heritage site. The boundary fencing is required for security.

In the context of the wider site and set against the landscaping scheme for the site, the fencing is considered to be appropriate. It will not appear out of place or overly prominent from a visual perspective. The proposed gates are of a similar style and are appropriate for the site.

It is noted, the proposal does not include any internal fencing/separation between the new and old technical sites. This is welcomed as the two developments need to interact from a functional and visual perspective.

5.2. Condition 11 – The Council's ecologist has confirmed that the limited operating hours and reduced lux levels set out in the additional covering letter have overcome initial concerns with the lighting. Therefore, the proposed lighting would not have a detrimental impact on ecology.

The design of the lighting is considered to be of an appropriate style for this site. It fits in with the lighting style in the wider Bicester Heritage site and works with the design of the buildings.

6. RECOMMENDATION

That Planning Condition(s) 10 and 11 of 20/00475/F be discharged based upon the following:
