

- 1. A4 THAT MAY BE PRINTED, LAMINATED AND USED AS A PUBLIC INFORMATION NOTICE.
- 2. PUBLIC INFORMATION NOTICE WILL BE ATTACHED TO A FENCE POST OR ON ITS OWN DESIGNATED TIMBER STAKE. THE LOWER EDGE OF THE SIGN SHOULD BE BETWEEN 1.0-1.5m FROM GROUND LEVEL SO THAT THE NOTICE IS EASILLY VISIBLE TO PEDESTRIANS.
- 3. SIGNS SHALL BE POSITIONED SO THAT THEY ARE CLEARLY VISIBLE TO ONCOMING USERS.
- 4. THE PROCESS OF DEPLOYING AND **REMOVING THE SIGNS SHOULD BE THAT** THEY ARE DEPLOYED JUST BEFORE WORKS STARTS AND BE REMOVED AS SOON AS IT IS FINSHED.
- 5. A WEEKELY MAINTENANCE CHECK OF THE PUBLIC INFORMATION NOTICES IS REQUIRED DURING THE WORKS TO ENSURE THE NOTICES REMAIN CLEARLY VISIBLE AND ARE NOT THE SUBJECT OF VANDALISM.
