As local residents of West Adderbury we find ourselves highly concerned regarding the proposed **recreational caravan park to include a new amenity building containing reception, toilets, showers and washing facilities** on the Milton Road. Although the application states that it is 'under consultation' the land has already been primed. Please could you explain why this is?

We have lived in West Adderbury for nearly a year having chosen this area due to the tranquil and safe rural village location. We felt this was a safe rural location to grow our family . However, this appears to be threatened by the proposed monstrosity which is a huge blot on the beautiful landscape. We feel misrepresented by the local Parish Council who have failed to publicise this, thank goodness for the WARA (West Adderbury Association).

Our objections consist of:

- Destruction to animal habitats situated in the substantial land (already seems to have taken place).
- Increase traffic flow & speed (which is currently an issue in the village).
- Personal safety at risk due to the influx of people and increase of traffic flow.

- This does not compliment our village and is not in keeping.
- Increased crime.
- We do not have the infrastructure to support this park which is suited to a town/city location.
- Threatens a decrease in house prices.
- A less desirable village to live.
