## Condition 13 Flood Risk Assessment – Launton Brook

We write to submit the further information required to enable partial discharge of this condition, specifically in respect of Launton Brook.

The Phasing Strategy (reference: 133735\_RW-EWR-XX-XX-DR-LE-012580 – 012605) submitted under our letter reference 133735-EWR-LTR-DEL-000036/LW and dated 3<sup>rd</sup> March 2020 set outs the phases that the East West Rail 2 Alliance will report on assets requiring further flood risk assessment.

The reports enclosed within this correspondence are part of the submission of further information required under Condtion 13, and set out the further flood risk assessment work and design undertaken since the Flood Risk Assessment July 2018 was submitted, in respect of Launton Brook.
