TRANSPORT AND WORKS ACT 1992: APPLICATION FOR THE PROPOSED NETWORK RAIL (EAST WEST RAIL BICESTER TO BEDFORD IMPROVEMENTS) ORDER

Condition 13 Flood Risk Assessment – Westbury Court, culverts C160924 & C160550

We write to submit the further information required to enable partial discharge of this condition, specifically in respect of Westbury Court, culverts C160924 & C160550.

The Phasing Strategy (reference: 133735_RW-EWR-XX-XX-DR-LE-012580 – 012605) submitted under our letter reference 133735-EWR-LTR-DEL-000036/LW and dated 3rd March 2020 set outs the phases that the East West Rail 2 Alliance will report on assets requiring further flood risk assessment.

The reports enclosed within this correspondence are part of the submission of further information required under Condtion 13, and set out the further flood risk assessment work and design undertaken since the Flood Risk Assessment July 2018 was submitted, in respect of Launton Brook.

For ease of you identifying which authorities you need to consult on each report, we have also set out which authority is responsible for the relevant watercourse (s)
