Hello Judith.

We have exactly the same problem with proposed S.106 funding for a new planning application in Steeple Aston that we had with the one below, covered in correspondence with you in January of this year. For some reason, Leisure Services do not automatically refer much-needed playground funding to your Department, and so it gets omitted from the proposals that they send to your planning colleagues.

So, can you please ensure that replacement of deteriorating playground equipment at our very

successful playground in Fir Lane, Steeple Aston is included in the S.106 proposals for application 20/02227/OUT. Our estimate of cost is now £25k, as matters have worsened in recent weeks.

Can you also please confirm that this need was referred to Planning in respect of the earlier application 19/02948/F? I ask this because the playground was not mentioned in the planning officer's report to committee listing S.106 requirements.

Thanks for your quick reply, Judith.

While the parish council would normally support a LAP on site, our experience of this at another housing site in the village (Lawrence Fields) is not good - it was used by older kids for the wrong reasons and has now been abandoned. We are therefore pleased that the applicants for the current scheme are planning to install a footpath linking the development to rest of the village, which parents and children would use to access our existing (very successful) playground in Fir Lane.

The elements of the playground most in need of replacement at present are the Pagoda (where parents sit and watch their children) and much of the enclosing fencing to the toddlers' playground. We think a budget of £15k is about right, but please don't hold us to that as we have not obtained estimates yet.

Hi Martin

Thank you for your e-mail, great to catch up yesterday.

In response to your questions, unfortunately play areas do not fall under my remit, I recommend you contact Judith Ward, Judith.ward@cherwell-dc.gov.uk from the landscapes team who should able to answer the queries.

With regards to the Community Hall facility contribution, either building would be eligible for funding under this heading as they are both community use facilities, as long as any project is looking to upgrade the facilities.

The purchase of indoor sport equipment is eligible for the indoor sport contribution as long as the equipment purchased will lead to an improvement of indoor sport.

Helen - many thanks for calling me yesterday. Can I clarify a few things?

- Is there also the possibility of a commuted sum for improvements to our existing children's play area? We have a very popular playground, installed around 2002, and some of the equipment is now wearing out. We would want to replace these items with new. We would not therefore claim the maximum amount available for a new facility (£23,068?), as that is not what is needed.

- We have two community buildings adjacent to each other in the village. One is the village hall and the other is our Sports and Recreation Centre. Would both be eligible for improvement under the heading of Community Hall?

- Both buildings house elements of Indoor Sports. Would the purchase of indoor equipment for the relevant sports be eligible under that heading?

- Finally, as discussed with you, we are looking into the nature of improvements that could be made to our football ground, under the heading of Outdoor Sports, and will let you know the outcome.
