e.g. Oak (T3) - fell because of excessive shading and low amenity value. Replant with one standard ash in same position.

T1 Sycamore, Trim clear of the BT cables and telegraph pole to create a 1m clearance.

T2+3 Laburnum and Sycamore, Trim clear of the BT cables to create 50cm clearance.

T4 Laburnum, Laetiporus FFB on the main stem at 1m, extensive dieback of a large proportions of the crown, Fell to near ground level.

T5 Spruce, Trim clear of the BT cables to create 50cm clearance.

T6 Malus, Reduce to 4.5m in height and reshape, removing approximately 60% of the canopy.

G7 Pine, Crown raise to provide a 2.5m clearance from ground level and prune away from the adjacent BT cable to create a 30cm clearance. Prune clear of neighbouring residence to create 1m clearance, remove major deadwood.
