Hi Matthew,

I am commenting on the above application from an arboricultural aspect.

I have studied the plans and the Arboricultural report;

Proposal – to build 9 dwellings

I was initially concerned about the encroachment into T1 as a B cat tree when it was feasible to develop outside the RPA since the incursion is only 3.2 %. It also required heavy pruning by 4 meters.

3.7. The proposed garage of plot 7 incurs marginally within the RPA of tree T1. The incursion amounts to 3.2% of the total RPA, falling beneath the 20% threshold for new surfacing within RPAs as guided by BS5837. To mitigate the impact of the garage construction within the RPA, it will be constructed using a reduced-dig method, such as a slab or cellular confinement system for the base / foundation. The remaining proposed built-form across the site is located outside the RPAs of retained trees.

I then wanted to get the figures and impact plan. I get a larger RPA and more impact. I then checked T19 and it also shows a larger RPA which will be impacted.



Can you ask for the cad drawing of the Arboricultural Impact Assessment so that I can verify my findings and rule out any error on my part.
