<b>Comments</b>	<input "="" https:="" type="text" value="Dear Sir/Madam, My objection is to the number of days proposed for use of the track and the increase in noise and traffic this brings. The track operators have knowingly ignored the planning system by operating well beyond the basic 28 (14+14) days allowed under 'Permitted Development Rights'. The proposal of 65 days a year is far too many and should remain at the current permitted amount. I also object to the slightly disingenuous way the operators are garnering support; the message seems to portray a threat of closure. I am not asking for closure of the track - simply no further development AND only 28 days use a year.
