Dear Ms Magnuson
I wish to object in the strongest possible terms to the way in which you and your colleagues are trying to railroad through a flimsy set of planning conditions allowing Wroxton Motocross track to continue operating.
The way you are trying to impose these conditions is nothing short of a disgrace because:
1. After Cherwell's planners persuaded the planning committee to give planning permission to this scar on the landscape, they promised that they would come up with a list of operating conditions after consulting with Hornton Parish council and the local member, Councillor Phil Chapman. You have broken that promise - there has been no meaningful consultation and the conditions you have come up with are flimsy, unenforceable and will simply store up trouble for the council in future, as it faces the prospect of expensive legal action if these conditions are not revised and strengthened.
2. Hornton Parish Council has provided you with a concrete set of operating conditions for the motocross track that have been drawn up by the sport's governing body and is in operation by other councils around the country. You have been given a copy of these conditions and yet you have chosen to ignore them.
3. Your head of democratic services has refused to allow Hornton Parish Council to address this Thursday's meeting to outline why this state of affairs should be stopped and a proper set of conditions be implemented. He claims that nothing new has occurred since the committee originally recommended planning permission: what about the fact that planning officers have broken their promise to consult local members and parish councils and the fact that they have come up with a set of conditions that are completely unfit for purpose?
