As homeowners in Hornton my wife & I would like to submit our strongest objection to the proposal on the motocross track on the edge of our village. Firstly we find it ludicrous that after years of operating (essentially) illegally next to our village that any consideration would be given to reward such behaviour by allowing an expansion of the operation. As a motorcyclist and former motocrosser myself I cannot imagine how you would let this motocross operation continue in this location. The noise pollution to the village of Hornton & environs on top of the damage to the local ecology seem to be reason enough to put a stop to this proposal. There looks to be no serious enforcement provisions for the noise requirements set forth in this proposal. That is to say nothing of my previous mention of rewarding an "outlaw" track to continue to operate. I have been through the planning process before and spent good money & time meeting the requirements of the Council. This makes a mockery of us who try to do our best to follow those rules.
