Although I am no longer chairman of the CPRE Cherwell District Committee, I am writing once again about the planning application 21/00517/F. I have followed the issue very closely and never in all my years as a viewer of applications have I seen one so unfairly and ineptly dealt with by CDC. Nor have I seen one in which the balance of right and wrong has been so tilted in favour of the wrong. Several hundred people will have much of their summers wrecked by a scheme put into place illegally and which for some incomprehensible reason was offered the chance of retrospective planning consent.

Nobody local is going to benefit from this application except the landowner who evidently cares nothing for the wellbeing or happiness of all the people who live within hearing distance of this appalling track. This is not just about Hornton. We get the noise at Alkerton (where I live), Shenington, Horley and elsewhere.

At the very least there should be a deferral of the item at the meeting this afternoon so that we can have a meeting at a later date when Hornton PC will be allowed to speak.
