Discharge of Condition 33 of Planning Permission 10/01642/OUT In relation to Dorchester Phases 5C, 7B and 8A

We write on behalf of our client, Heyford Park Developments, to submit an application seeking the discharge of Condition 33 of planning permission reference 10/01642/OUT, in respect to Dorchester Phases 5C, 7B and 8A at Heyford Park, Camp Road, Upper Heyford, Oxfordshire, OX25 5HD.

Condition 33 states that:

"For each phase or sub-phase of the development, no works shall be undertaken until such times as a detailed scheme of noise assessment and possible sound insulation measures for residential units (including a timetable for its implementation) has first been submitted to and approved in writing by the Local Planning Authority. That scheme shall be implemented in accordance with the approved details."
