Planning reasons. The site is clearly beyond the boundaries of the village but is not, as I understand the applicant, not being classed as an exception site but a site for entry level Housing using new legislation about to be announced to do so.

This clearly will drive a coach and horses through our present policies and open up all villages to speculative applications that will lead to ordinary housing once the principles have been established.
