Re planning application no. 21/01224/OUT Bicester Motion

I have scrolled through Cherwell Planning applications, but can find no where to lodge an objection, so am emailing you.

I am quite worried on reading that Bicester Motion are considering what appears to be a race track at the Bicester Heritage Airfield. This airfield is directly opposite a Care Centre, which is home to several older people. The care center comprises of a Nursing Wing, a Residential Wing & 16 independent cottages which provide Extra Care Housing.

Since last summer, when Bicester Heritage changed the direction of the planes taking off, the planes have taken off directly over the Cottages at Cherwood Care Centre. They are extremely low & extremely loud. There have been times when we have wondered if they would actually clear the roofs of the cottages. It is sometimes impossible to have a conversation when these planes are going over. Coupled with the fact that some of these planes are old war planes & some of the residents will be able to remember " The Blitz", I find this extremely inconsiderate & thoughtless.

Now I read that there are plans for a potential race track around the perimeter. This will cause excessive & unacceptable noise. I would like to register my objection to this planning application, on the grounds of excessive & unacceptable noise, & unnecessary disturbance to the residents of Cherwood Care Centre, (where my Mother is a resident).

I feel I must also point out the close proximity of another Care Home - Langford Grange, which is just across the road from Bicester Heritage Airfield, where the elderly residents would be disturbed by the excess noise.

I feel Bicester Motion need to be more aware of their surroundings & be more thoughtful to the elderly residents living very nearby.
