Apologies for the delay in getting back to you.

I have checked the revised details against the comments which Frances submitted, and would make the following further comments regarding the accommodation schedule:

- 1. The proposed types and sizes of affordable dwellings are acceptable and accord with the requirements Frances set out in her comments
- 2. Confirmation of the tenure mix is still required, the tenure plan refers simply to "affordable units". On this development the requirement is for 7 social rented and 3 intermediate.
- 3. I would suggest that the intermediate dwellings consist of 2no. 2-bed 4-person and 1no. 3-bed 5 person dwellings.
- 4. We require confirmation that the dwellings sizes will be 1-bed 2-person, 2-bed 4-person and 3bed 5-person
- 5. We welcome the confirmation that all affordable dwellings will meet NDSS requirements. We require this to be made clearer on the plans, as it has not been confirmed that the larger sizes are being provided as set out in point 4. We require the plans to state the exact dwelling size and GIA.
- 6. We welcome the confirmation that 60% of the affordable dwellings will be constructed to M4(2) requirements and that these are shown on the plans.

I hope these points are helpful, please let me know if you would like to discuss anything further.
