Hi Charlotte,

I've had a look at the area that is identified for NBG – it is located on the main hill. Although this land does provide open space, it doesn't appear to be part of the 'landscaped open space' provision and I can't find anything to suggest it forms part of an existing planting scheme.

Landscaping was a reserved matters and this land is shown in phase 3 of the phasing plan, so has not yet come forward. If you are happy with the BNG provision, we probably just need to make sure it doesn't get double counted if there is a requirement for more BNG as part of future phases of the development.

With regard to condition 6 (Great crested newt precautionary working methodology) I am happy for this condition to be discharged on the basis of the documents submitted.

Similarly – condition 8 (Biodiversity Net gain) is generally fine however I was slightly unclear as to whether, given the proposed off site compensation land is already part of the wider site, whether this was already land destined to be planted in this way as part of the wider site proposals and obligations? If it is this would not represent a true gain for biodiversity. Is there an easy way of checking this?
