I am picking up the comments made to Bernadette Owens regarding the landscaping for the above application.

Firstly, the Hard Landscaping proposed is detailed on plan No: 2612-02 Rev PL4 (A plan prepared by Garrett Mckee Architects) which was submitted with this application.

Further engineering detail for this hard landscaping design is noted on drawing no: P21-002-101-C1 (A drawing prepared by Simpson TWS) also submitted with the application.

The Soft Landscaping has already been implemented and planted within the area annotated with an orange line of the attached drawing; with the Trees and shrub planting along the Eastern side of this application area forming the Western side of the Avenue of trees along the new spine road, now named Technology Drive. This soft landscaping plan was agreed and approved at the discharge of conditions to the outline planning consent stage; Consent No. 16/00533/DISC.

In order to ensure the Park is developed as a cohesive whole, many engineering and environmental strategies and management plans were established at the Outline planning consent stage in order to ensure that they could be applied consistently across the scheme. The park wide Soft Landscaping scheme is one of these plans.
