I'll advise my client that you aren't happy for the condition to be discharged until the PXA has been approved. In this circumstance, as Condition 43 applies only to the main site, I assume that the PXA will concentrate solely on the now completed mitigation works on the main site. As the drainage outfall (if mitigation were required after the upcoming evaluation) would be subject to a separate condition, it would presumably have a separate PXA or could directly feed into the publication for the main site – whichever is agreed at the time.

Thanks for the email. Understood regarding the publication requirement and the need for you to review a draft before its submitted to the journal. I understand then that we are agreed the fieldwork is completed and that there is no constraint for the site to be brought forward in its entirety for construction, with no need for further archaeological inputs.

In terms of the drainage works, just so I am clear, my reading of your comment is that we would need to provide a standalone evaluation report (as it will be subject to a separate planning application), but that any subsequent mitigation would need to be included in the publication report for the main site, as you have directed.

I assume that we can now seek full discharge of the condition, under the provision of paragraph 4.8 of the agreed WSI, which states:

Condition 43 can be discharged once all fieldwork on site is completed, and on provision of written confirmation to the Council's Advisor that the post-excavation works are underway and a suitably robust and flexible budget has been set aside by the client to enable the completion of the work to publication (if necessary) or the production of a final report, and the deposition of the archive.
