The applicant has submitted a post excavation assessment to discharge condition 44 of permission 20/00277/DISC.

This post excavation assessment (v2) was initially provided to us for our comment on the 29th June 2021 and was immediately amended as the consultant realised that this version had omitted a number of evaluation trenches also undertaken as part of this work. This revised version (v3) was submitted to us for our comments in lien with the agreed written scheme of investigation on the 5th July 2021.

We provided advice to EDP, the applicant's archaeological consultants, that this v3 version of the assessment was not acceptable and that a number of revisions would need to be undertaken before we could agree that it was acceptable on the 30th July 2021. They responded on the same day to say that they would speak to Oxford Archaeology and send me a revised version.

No such revised version has been submitted to us and no post excavation assessment has been agreed for this site as set out in the agreed written scheme of investigation.

As such we would not recommend the discharge of condition 44 at this stage.

Once the post excavation assessment has been agreed with County Archaeology then a copy of this along with a letter confirming that the funding has been agreed to deliver the publication and archiving as set out in the agreed assessment before this condition would have been met.
