1. APPLICATION SITE AND DESCRIPTION OF APPROVED DEVELOPMENT

1.1. Planning permission has been granted for 7 new age restricted dwellings at the site. There is a current Section 73 application for changes to the design pending consideration. The site is located at the edge of Deddington and within the Conservation Area and the setting of Deddington Castle. The development has not yet commenced on site

2. CONDITIONS PROPOSED TO BE DISCHARGED

- 2.1. The current application seeks permission to discharge condition 22 which requires a Written Scheme of Investigation for archaeology to be submitted and approved in writing. An amended WSI has been submitted from Red River Archaeology Land at Clifton Road, Deddington Written Scheme of Investigation for Archaeological Watching Brief Project RR0316 Rev 2 (27.09.21).
- 2.2. The application initially included Condition 23, but this condition cannot be discharged because (i) it requires compliance with condition 22 and (ii) the works have not yet been undertaken. During the course of the application condition 23 has been withdrawn from this application.
