"The golf course works have not commenced. A contractor has been identified and letter of intent issued pending confirmation of a commencement date following discharge of the s106 obligation. Some site investigation works have been completed over the last month, including geotechnical boreholes (we had a small drilling rig on site for a couple of weeks), tree surveys, and dimensional checks. We also have further surveys to complete in the coming months, including soils classification work. So there has been some activity on site but nothing related to the golf works."
