HI Shona,

I have looked at the proposals and have no objections. Although 13 trees and 2 groups of trees are going to be removed they are internal to the site. The outer most trees are going to be retained and protected in accordance with BS 5837:2012. As long as the trees to be retained are protected as set out in the Tree Retention and Protection plan then the trees should suffer no ill effects of the proposed development. In terms of the trees to be planted, I am happy with the species choice. We would need to see the tree pit design.

Please could the below conditions be attached to any consent given.

C7 Retained Tree

- a) No retained tree shall be cut down, uprooted, damaged or destroyed, nor shall any retained tree be pruned in any manner, be it branches, stems or roots, other than in accordance with the approved plans and particulars, without the prior written approval of the Local Planning Authority. All tree works shall be carried out in accordance with BS3998: Recommendations for Tree Works.
- b) If any retained tree is cut down, uprooted, destroyed or dies, another tree shall be planted in the same place in the next planting season following the removal of that tree, full details of which shall be firstly submitted to and approved in writing by the Local Planning Authority.

In this condition a "retained tree" is an existing tree which shall be retained in accordance with the approved plans and particulars; and paragraphs (a) and (b) shall have effect until the expiration of five years from the date of the [insert].

Thereafter, the development shall be carried out in accordance with the approved details and specifications.
