Dear Caroline, further to your consultation on the above application I can confirm that TVP welcome to recognition by the applicants of the need to provide developer contributions in accordance with the advice as set out in the Councils Developer Contributions SPD and Policies in the adopted Local Plan.

As stated previously, and accepted by the Council and by the inspector determining the appeal at Parcel 4200 (14/01675/OUT), there is acceptance that the impact of substantial housing growth at NW Bicester will place additional demand upon the ability of TVP to police both new and existing communities.

It is necessary therefore for developer contributions to mitigate the impact on neighbourhood policing through the provision of \$106 contributions to mitigate the impact of development. The financial contribution, based on the assumed scale of development of 3100 units at the previously accepted and

established rate, will be utilised to provide additional infrastructure for the local Neighbourhood teams.  $3100 \times 151.30 = £469,030$
