Apologies for my delay due to being unavailable/unwell.

With the proposal, I have a broad 'observations' arising from the relatively limited provision of land and facilities to specifically support the development of businesses and jobs. Whilst noting a range of housing and facilities that indirectly support the Council's economic growth objectives, I would suggest that the balance and extent of development is considered as part of the Local Plan Review. This is particularly so given the extension of development beyond the current Local Plan boundary.

Meanwhile, in any detailed planning proposal, I would suggest a detailed economic assessment as to how the proposal would integrate with and enhance the town/district/county/Arc's economic strengths. This should include, for example, a detailed training and skills plan to prepare well in advance for both the construction and operational phases of all aspects of the development.
