Hi Andrew,

With regards to the AMS. I appreciate your comments however, there are items outstanding which could be expected in a full report, and which I will require before I can support the discharge of condition. If these can be included then I'm content a supplementary report won't be required.

- Arboricultural supervision. The current AMS highlights supervision of the no-dig driveway (which I believe is no longer proposed?) In addition to pre-construction barrier inspection. I would expect an AMS to provide details of an auditable supervision proposal which should extend from the pre development stage, to mid development monitoring, and post development withdrawal of tree protective measures. This monitoring proposal should include contact details and a strategy for reporting issues to CDC should they arise.
- In line with the above. The AMS suitably details the CEZ of trees aligns with the RPAs however, as RPAs are of course theoretical, what is the process if excavations adjacent to RPA fencing reveals roots? Expansion is required on working practice when working adjacent to RPAs, such as root pruning, arboricultural supervision etc.
- The AMS details barriers will remain in place until the completion of the 'main construction period'. I'd like confirmation barriers will remain in place until all possible risks to retained trees have departed the site, and that this will be signed off by the monitoring arboriculturalist.
- CEZ of landscaped areas to the north of the proposal. I appreciate the approach specified in the follow up email however I feel a compromise needs to be made between no fencing, and fencing where fencing isn't required. There appear to be areas of retained vegetation adjacent to proposed footpaths which are not protected by fencing. Ground compaction etc. remains a risk regardless of the operation being completed and measures to prevent/mitigate this are still required despite the risk being lower than what could be

expected in the main development area. If it can be confirmed what measures could be taken here I'm glad to discuss practical options.

I'm available Friday to discuss in more detail if required.
