Outline Planning Application - For the development of up to 370 homes, public open space (including play areas and woodland planting), sports pitches and pavilion, drainage and engineering works, with all matters reserved (appearance, landscaping, layout and scale) except for vehicular and emergency accesses to Bicester Road: Land at Gosford (part of allocation PR7a)

Pegasus Group is instructed by Barwood Development Securities Ltd and the Trustees of the Philip King Homes Trust (**the Applicant**) to apply for outline planning permission for 370 homes and associated works, at Land at Gosford (part of allocation PR7a)
