The single road that runs past our home is already a rat run for people avoiding all the traffic on the b4100 and a43 so trying to imagine what the traffic would be like if this warehousing was in place is unimaginable. Every evening and every morning at peak times the b4100 is massively congested so to think what the traffic to these warehouse will bring is unthinkable!</p> <p>The POLLUTION Articulated lorries spewing out diesel fumes 24hrs a day.</p> <p>As these warehouses will be running 24 hrs a day 7 days a week, they will be permanently lit, how can my family ever live normally again with permanent security lighting on, how are we suppose to sleep when these warehouse are 45 meters away from our bedroom windows, and what about the NOISE, incase these developers hadn't noticed this is the rural county side, not the M40 motorway !</p> <p>The size of these proposed warehouses are 100 feet in height this is over 5 times higher than our barn, when my husband and asked permission to build a double garage we had to build it 4th lower than the hedge line so the top of our garage roof could not be seen at immense expense I might add your more than welcome to come and see for yourselves )</p> <p>And what about the WILDLIFE we have a garden full of beautiful birds, owls, hawks kytes , woodpeckers, finches just to name a few, we have bats , foxes, muntjac, squirrels, in our pond we have frogs and toads.
