Hybrid Poplar, loss of codominant stem during high winds. Competing with adjacent native species. In close proximity to neighbouring structure for long term retention. Fell to allow adjacent trees to become fully mature, with good form and condition.
Birch, windblown. Clear partially failed tree.
You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
