The County's position regarding Section 106 contributions is as set out in its initial response to this application of 17 August 2022.

Comments

The County's response to consultation of 18 October 2022 left an objection to this planning application in place for the following reasons.

- A cycle way extension was still required.
- A long section and vertical alignment were still required.
- A Stage 1 Road Safety Audit was still required.

These items are addressed in the latest set of application documents and are dealt with in turn below.

Cycle Way Extension

The email from Maddox Associates of 25 October 2022 points out that the approved outline application under 16-02586-OUT does not make provision for a cycle way extension and asserts that such a facility is not necessary. As it was not requested under the outline planning and the developer is not open to extending the cycle way, the County can not insist this is included. This is therefore no longer a reason for objection.

Long Section and Vertical Alignment

The County has reviewed the long sections and vertical alignments at the access and they are acceptable. This is no longer a reason for objection.

Stage 1 Road Safety Audit

The County has reviewed the Final Stage 1 Road Safety Audit of 14 October 2022 and the subsequent designers response report of 19 October 2022. These submissions are acceptable and this is no longer a reason for objection.

Further Matter

As previously noted in the County's response of 18 October 2022, it is again noted at this stage that the highway boundary plotted is not necessarily to true highway boundary, as there is the caveat to the highway boundary that if there is a roadside ditch then the highway boundary reverts to the road-side edge of the ditch. If this is the case, then the developer will need to apply for an AP1 application with land registry to claim title to the unregistered ditch in order to be able to dedicate this as highway.
