- a) The parking of vehicles of site operatives and visitors;
- b) The routing of HGVs to and from the site;
- c) Loading and unloading of plant and materials;
- d) The creation of storage compounds, or any storage of plant and materials used in constructing the development, including a scheme for their subsequent removal and restoration of the land;
