1 Leyland Cyprus Tree.

Remove 1 Leyland Cyprus Tree - No other works proposed.

The tree is not subject of a TPO, but is within a conservation area.

The tree is directly adjacent to the rear boundary wall, the boundary wall is a traditional stone wall, which we are trying to preserve. The tree (as can be seen from the photographs) branches brush overhead electricty supplies. This has been brought to the attention of

supplier who has in the past trimmed the overgrowth, leaving an odd shape.

The tree's overhanging branch to the rear stone wall only effect a farmers field, which contains no cropts and the occasional cow. There are no footpaths or official access to this area of the field.

All debris will be removed and recycled.

You might find it useful to contact an arborist (tree surgeon) for help with defining appropriate work.
