Golby and Luck's Landscape Plan (22/02570/REM) and Ecology Solutions' LBEMP appear to have been produced in isolation and therefore conflicting requirements are evident, resulting in confusion. A single LEMP is required to ensure the landscape/ecological contactor is certain of the maintenance procedures required.

The additional tree species, Acer campestre should be included in the report.

Our ecologist Charlotte Watkins will be able to comment on the ecological elements of the combined LEMP.
