Thank you to all involved in developing the draft Training & Employment Plan.

The applicant has incorporated many of the comments previously submitted (attached). To aid its implementation, some clarification is required:

Para 1.4 – Good to see the target of 3 apprenticeship starts but the detail should be expanded upon – activity, level, etc.

Para 2.7 – Abingdon & Witney College (not Whitney)

Para 2.8 – The Bicester Construction Skills Centre is operated by Abingdon & Witney College (i.e. it is one and the same and should be clarified to avoid confusion).

Para 3.4 – Good to see the past performance and it would be helpful to understand the career paths subsequently followed.

Para 4.1 – The sentence needs refining.

- Overall, Monitoring has improved although without clearer targets, it is unclear how it will be used to plan ahead and to record progress?
- Also, is the attached OxLEP template being used to record, or does the contractor have their own?
- The bi-annual meeting suggestion is welcomed. The plan would helpfully identify the person and/or organisation (within Parkway?) who is to lead the delivery, to be supported by CDC Economic Growth and OxLEP skills.
- An early discussion would be welcomed.
